

RENTAL AGREEMENT  
LANCASTER COUNTY  
CAT 256C SKID LOADER RENTAL  
Bid No. 4096

THIS LEASE AGREEMENT, made and entered into by and between the County of Lancaster, Nebraska, on behalf of the Lancaster County Engineering Department, hereinafter referred to as "County" and NMC, Inc., hereinafter referred to as "Owner".

WHEREAS, the County, through the Lancaster County Engineering Department (hereinafter referred to as "Engineer") is responsible for providing road improvement and maintenance to the streets and roads located within its jurisdiction; and

WHEREAS, it is desirable for the County to enter into a rental agreement for a 4-Wheel Skid Loader in order to aid the Engineer in the execution of its duties; and

WHEREAS, Owner owns a Cat 256C 4-Wheel Skid Loader suitable to the needs of the Engineer and is willing to rent such Cat 256C 4-Wheel Skid Loader to the County.

NOW THEREFORE, in consideration of the mutual covenants contained herein, it is agreed by and between the parties hereto, as follows:

1. The Owner agrees to rent to the County for \$325.00 per month and other good and valuable consideration a Cat 256C 4-Wheel Skid Loader with 78" bucket, Serial Number 0DWS01982 (the Vehicle). The County agrees to make full payment of \$3,900.00 and other valuable consideration within thirty (30) days of return of the Vehicle. As additional consideration the City agrees to pay \$12.00 per hour for every hour in excess of 250 hours on the hour meter of the above Vehicle upon the return of the Vehicle at the end of the rental term.
2. The Owner agrees to and shall have the following duties and responsibilities
  - A. To rent and provide to the County a Cat 256C 4-Wheel Skid Loader with 78" bucket, Serial Number 0DWS01982.
  - B. To provide and pay for all maintenance, service, repair, taxes, licensing and registration cost for the Vehicle described above throughout the term of this rental agreement, as follows:
    1. The Owner agrees to honor the manufacturer's warranty and will perform any necessary warranty repairs. In the event that a warranty repair should take over four (4) hours to complete, then the Owner shall provide and deliver a loaner Vehicle to the County.
    2. The Owner reserves the right to exchange the Vehicle for a new unit of the same make and model at any time during the rental term at no additional charge or cost to the County.
  - C. To deliver the Vehicle at the beginning of the rental period and pick up the Vehicle at the end of the rental term. The time for Delivery and pickup of the Vehicle shall be mutually agreed upon by the parties.
  - D. To pay all cost of all licensing, registration of the Vehicle in the Owner's name, and such taxes as are specified shall be paid for by the Owner, and the Owner shall pay all other taxes and/or government assessments, fees and charges imposed on or in connection with the Vehicle operated pursuant to this agreement.

3. The County agrees to and shall have the following responsibilities:
  - A. The County shall be responsible for the cost of all gasoline, oil required between changes, and all washing, polishing and storage, to the extent necessary to maintain the Vehicle in good condition.
  - B. The County will pay for any damage incurred to the Vehicle during rental term, excluding normal and fair wear and tear, upon return of the Vehicle at the end of the rental term.
  - C. The County will pay for all repairs and maintenance not covered by the manufacturer's warranty.
  - D. The County shall keep and maintain the Vehicle in good operating condition and working order, using as a guide the maintenance program prescribed in the Operator's manual, and shall perform all preventative maintenance required to insure full validation of the manufacturer's warranty.
  - E. Insure the vehicle during the rental term. Prior to delivery of the Vehicle, proof of insurance will be provided to the Owner.
    1. Insurance shall be endorsed to provide that Insurer will notify the Owner immediately in the event the insurance should be materially altered or canceled.
    2. The Owner and the County, their agents or employees, shall comply with all the terms and conditions of said insurance policy, including the immediate reporting of all accidents to the Owner, and do all things necessary to protect or preserve the other party's rights as a named insured in said insurance policy.
    3. The County agrees to indemnify and hold harmless the Owner and its Officers against all losses, liabilities, damages, injuries, claims, demands, costs and expenses of every kind, whether or not covered by insurance, including legal fees and disbursements arising out of and in connection with the use, condition, and operation of the Vehicle during the rental term.
  - F. To provide transportation of the Vehicle during the rental term.
  - G. Make the Vehicle available to the Owner for any and all warranty repairs.
3. This Rental Agreement shall take effect on upon execution of the parties and shall continue for one year from the date of execution. This will be a one (1) year agreement.
4. This Rental Agreement may be terminated by either party hereto at any time by rendition of written notice of such intent to the other party at lease fourteen (14) days prior to the proposed date of termination.
5. The parties hereby agree that this agreement constitutes the entire understanding of the parties and supersedes all prior contracts, agreements and negotiations between the parties whether verbal or written.
6. This agreement shall be governed and interpreted by the Laws of the State of Nebraska without reference to the principles of conflicts of law.
