RE: Report of Claims Against the City of Lincoln for May 1 through May 15, 2014

Dear Mayor & Council:

The following is a report of claims against the City of Lincoln which have been disposed of, or are pending, for the period of May 1 through May 15, 2014. This report will describe the claims and the dispositions or status of these claims.

DENIED CLAIMS:

Vern Thompson filed a claim during the month of April, 2014, in the amount of \$96.00 for damage allegedly incurred to water softener when water service was turned back on after water main repair was done. This claim has been reviewed by this office and has been **denied**.

Doug Friendt filed a claim during the month of May, 2014, in the amount of \$1,014.69 for damage incurred to vehicle at Center Park parking garage. This claim has been reviewed by this office and has been **denied**.

ALLOWED/SETTLED CLAIMS:

Blanca Rincon-Flores filed a claim during the month of March, 2013, in the amount of \$8,000 for injury allegedly incurred as the result of accident involving a snowplow. This claim has been reviewed by this office and has been **settled** in the amount of \$3,500.00.

Jennifer Woodard and Joseph Rolenc filed a claim during the month of March, 2014, in an unspecified amount for damages incurred when overhead traffic signal pole fell on claimants' vehicle. The property damage portion of this claim has been **settled** in the amount of \$4,268.00.

Jackie Sidders filed a claim during the month of April, 2014, in the amount of \$4,400.00 for damages incurred as the result of water main break. This claim has been reviewed by this office and has been **settled** in the amount of \$3,006.44.

Brenda Soto filed a claim during the month of April, 2014, in the amount of \$1,131.94 for damage incurred to vehicle when struck by hose that had become disconnected from fire truck as it passed by claimant's vehicle. This claim has been **settled** by the Risk Management office in the amount of \$421.43.

Matthew Rauert filed a claim during the month of April, 2014, in the amount of \$726.30 for damage incurred to vehicle when struck by an Aging van. This claim has been **settled** by the Risk Management Office in the amount of \$726.30.

Michael Karloff filed a claim during the month of May, 2014, in the amount of \$1,211.43 for damage incurred to vehicle when struck by a StarTran bus. This claim has been **settled** by the Risk Management Office in the amount of \$1,211.43.

PENDING CLAIMS:

Leonard Hill filed a claim during the month of June, 2012, in the amount of \$2,178.23 for expenses incurred for repair of water service which claimant alleges was caused by storm sewer installation and subsequent improper repair of water service. This claim is under review and is **pending**.

Sharon Joyce filed a claim during the month of July, 2012, in an unspecified amount for injury incurred when claimant allegedly fell due to a hole in grass near street. This claim is under review and is **pending**.

Priestcellius R. Brown Jr. filed a claim during the month of July, 2012, in the amount of \$25,000 for alleged injury incurred as the result of an accident involving police vehicles. **Priestcellius Brown Sr.** filed a separate claim for medical expenses incurred for his son arising from the accident. These claims are under review and **pending**.

Cynthia Gustafson filed a claim during the month of November, 2012, in the amount of \$17,000 for alleged injury incurred while claimant was a passenger on a StarTran bus. This claim is under review and is **pending**.

State Farm Insurance as subrogee of Floyd Brown filed a subrogation claim during the month of February, 2013, in an unspecified amount for medical benefits paid as the result of an accident involving a StarTran bus. This claim is under review and is **pending**.

Robert T. Murray filed a claim during the month of April, 2013, in an unspecified amount for alleged damage incurred to sod/groundcover by L.E.S. equipment. This claim is **pending** review and ratification by the L.E.S. Administrative Board.

Dixie Koch filed a claim during the month of April, 2013, in an unspecified amount for injury allegedly incurred when she tripped on a sign that was lying on sidewalk. This claim is under review and is **pending**.

Titus DeBoer filed a claim during the month of April, 2013, in an unspecified amount for damage allegedly incurred to tire as the result of a pothole. This claim is under review and is **pending**.

Dean and Lynda O'Connell filed a claim during the month of May, 2013, in the amount of \$513.60 for damage allegedly incurred to sod and sprinkler by City Water personnel. This claim is under review and is **pending**.

Carla Brassell filed a claim during the month of July, 2013, in the amount of \$25,000 for injury allegedly incurred when claimant fell on ice outside the Lincoln Children's Museum. This claim is under review and is **pending**.

Jeffrey L. Kirkland filed a claim during the month of July, 2013, in the amount of \$1,966.21 for medical billings incurred when claimant was taken to hospital by Lincoln police. This claim is under review and is **pending**.

Phoenix Loss Control on behalf of Time Warner filed a claim during the month of October, 2013, in the amount of \$1,743.27 for damage allegedly incurred to underground cable. This claim is **pending** review and ratification by the L.E.S. Administrative Board.

Larry Day filed a claim during the month of November, 2013, in an unspecified amount for damage incurred to a tree during installation of underground electrical utility. This claim is **pending** review and ratification by the L.E.S. Administrative Board.

Travis Hoveling filed a claim during the month of November, 2013, in an unspecified amount for damages incurred as the result of an accident that occurred in the roundabout at 14th and Superior. Claimant alleges that the accident was proximately caused by the negligent development, construction, improvements, regulations and operation of the roundabout by the City. This claim is under review and is **pending**.

Anthony Baumert and Angela Boule filed a claim during the month of December, 2013, in the amount of \$1,580.00 for damage allegedly incurred to sewer pipe as the result of trenching by L.E.S. personnel. This claim is **pending** review and ratification by the L.E.S. Administrative Board.

James McCown filed a claim during the month of December, 2013, in an unspecified amount for damage incurred to vehicle when allegedly struck by either a Lincoln Electric System vehicle or a Lincoln Water System vehicle. This claim is under review and is **pending**.

Shawnadee and Mark Morris filed a claim during the month of January, 2014, in an unspecified amount for damages incurred as the result of water main break. This claim is under review and is **pending**.

Black Hills Energy filed a claim during the month of January, 2014, in the amount of \$292.58 for damage incurred to gas line during excavation by L.E.S. at 8801 South 33rd Street. This claim is **pending** review and ratification by the L.E.S. Administrative Board.

Jordan Kaiser filed a claim during the month of January, 2014, in an unspecified amount for damage incurred as the result of water main break. This claim is under review and is **pending**.

Doralu Streeter filed a claim during the month of January, 2014, in an unspecified amount for injury allegedly incurred when claimant fell on the 10th Street pedestrian overpass. This claim is under review and is **pending**.

Charlie and Bonnie Huff filed a claim during the month of January, 2014, in the amount of \$20,647.18 for alleged damages incurred as the result of sewer back-up. This claim is under review and is **pending**.

This claim is **pending** review and ratification by the L.E.S. Administrative Board.

Joyce Bumstead filed a claim during the month of March, 2014, in the amount of \$12,121.50 for damages incurred as the result of sewer back-up. This claim is under review and is **pending**.

Jennifer Woodard and Joseph Rolenc filed a claim during the month of March, 2014, in an unspecified amount for damages incurred when overhead traffic signal pole fell on claimants' vehicle. **Farmers Insurance** filed a subrogation claim for medical benefits paid on behalf of Jennifer Woodard who was operating the vehicle at the time of the incident. These claims are under review and **pending**.

Troy Hough filed a claim during the month of April, 2014, in the amount of \$175.00 for damage allegedly incurred to fence when struck by L.E.S. equipment. This claim is **pending** review and ratification by the L.E.S. Administrative Board.

Phoenix Loss Control on behalf of Time Warner Cable filed a claim during the month of April, 2014, in the amount of \$645.93 for damage allegedly incurred to cable by L.E.S. This claim is **pending** review and ratification by the L.E.S. Administrative Board.

Cheever Construction filed a claim during the month of April, 2014, in the amount of \$85,526.00 for payment of roof repair at 6117 Havelock Avenue resulting from Urban Development loan activities involving the property. This claim is under review and is **pending**.

Jeanen France filed a claim in an unspecified amount for injury incurred as the result of fall on sidewalk. This claim is under review and is **pending**.

Tyler McManaman filed a claim in the amount of \$374,968.00 for injury incurred when claimant was arrested by Lincoln police. This claim is under review and is **pending**.

Lindsay Kracman and Jordon Khedir filed a claim in the amount of \$142.00 for cost of electrician to diagnose problem with L.E.S. service. This claim is **pending** review and ratification by the L.E.S. Administrative Board.

PENDING TORT LITIGATION:

Lailoma Ayubzai filed a claim during the month of April, 2010, in the amount of \$1,000,000 for alleged damages incurred as the result of a motor vehicle accident. Claimant's vehicle was struck by a vehicle operated by an individual who was fleeing from police. This claim was withdrawn and suit was filed in the Lancaster County District Court. Litigation is **pending**.

Candace Polfus, individually and on behalf of her minor child, Robert M. Polfus, filed a claim in February, 2012, in the amount of \$50,000 for alleged injury incurred to Robert Polfus at Uni Pool. This claim was reviewed by this office and denial was approved by the Lincoln City Council on July 30, 2012. Suit was filed in the Lancaster County Court. Litigation is **pending**.

Arok Atem filed a claim during the month of March, 2012, in the amount of \$1,000,000 for injury allegedly incurred when claimant was arrested and transported to the Lancaster County Jail. This claim was withdrawn and suit was filed in the Lancaster County District Court. The case has been transferred to the U.S. District Court. Litigation is **pending**.

Angela Schmohr filed a claim during the month of July, 2012, in the amount of \$175,000 for alleged injury incurred as the result of accident involving a police vehicle. Suit was filed in the Lancaster County District Court. Litigation is **pending**.

Leroy Duffie filed a claim during the month of August, 2012, in the amount of \$200,000 alleging that he was injured during an incident involving Lincoln police. This claim was withdrawn and suit was filed in Lancaster County District Court. The case has been transferred to the U.S. District Court. Litigation is **pending**.

Ben and Leigh Lewis on behalf of Nathan Lewis filed a claim during the month of October, 2012, in the amount of \$220,000 for injury incurred when Nathan Lewis was riding his bicycle on railroad bridge at Wilderness Park and the wheel of his bicycle got caught between two railroad ties causing him to fall. This claim was reviewed by this office and denial was approved by the Lincoln City Council on February 25, 2013. Suit was filed in the Lancaster County District Court. Litigation is **pending**.

State Farm Insurance as subrogee of Insured, David Tarrence filed a claim during the month of October, 2012, in the amount of \$17,615.65 for damage incurred to Insured's truck when it collided with an alleged low hanging tree limb. This claim was reviewed by this office and denial was approved by the Lincoln City Council on February 25, 2013. Suit was filed in the Lancaster County District Court. Litigation is **pending**.

Dawn Amory filed a claim during the month of November, 2012, in the amount of \$250,000 for alleged injury incurred as the result of trip and fall on sidewalk. This claim was reviewed by this office and denial was approved by the Lincoln City Council on December 17, 2012. Suit was filed in the Lancaster County District Court. Litigation is **pending**.

Michael Lecher filed a claim during the month of December, 2012, in the amount of \$250,000 alleging that Lincoln police officers used excessive force when arresting him. This claim was reviewed by this office and denial was approved by the Lincoln City Council on March 25, 2013. Suit was filed in Lancaster County District Court. Litigation is **pending**.

Nationwide Insurance Co. as subrogee of Insured, James and Marti Harris filed a claim during the month of April, 2013, in the amount of \$9,799.42 for damage incurred to Insured's vehicle as the result of accident involving a police vehicle. This claim was reviewed by this office and denial was approved by the Lincoln City Council on June 17, 2013. Suit was filed in Lancaster County Court. Litigation is **pending**.

Nicole Ulm filed a claim during the month of April, 2013, in the amount of \$200,000 for alleged damages incurred as the result of an accident involving a vehicle that was being operated by an individual who was fleeing from Police. This claim was withdrawn and suit was filed in the Lancaster County District Court. Litigation is **pending**.

Matthew Thomas filed a claim during the month of March, 2013, in an unspecified amount for damages incurred as the result of accident involving a Public Works vehicle. Suit was filed in the Lancaster County District Court. Litigation is **pending**.

Stephanie Bussinger filed a claim during the month of March, 2013, in an unspecified amount for alleged injury incurred as the result of accident involving a Public Works vehicle. Suit was filed in the Lancaster County District Court. Litigation is **pending**.

John Crow filed a claim during the month of October, 2012, in the amount of \$200,000 alleging that he was misclassified as an independent contractor and wrongfully terminated from his position as the PGA Professional for the Holmes Golf Course. This claim was reviewed by this office and denial was approved by the Lincoln City Council on November 19, 2012. Suit was filed in Lancaster County Court. Litigation is **pending**.
