

ORDINANCE NO. \_\_\_\_\_

1           AN ORDINANCE to adopt the “Corporate Limits Map” dated July 1, 2003 as the  
 2 established and fixed boundaries of the corporate limits of the City of Lincoln in the County of  
 3 Lancaster, State of Nebraska.

4           WHEREAS, Ordinance No. 8730, as amended, established and fixed the corporate limits  
 5 of the City of Lincoln, Nebraska; and

6           WHEREAS, the corporate limits of the City of Lincoln as fixed and established by  
 7 Ordinance No. 8730, as amended, includes all lands automatically annexed into the City of  
 8 Lincoln by the City of Lincoln’s approval of final plats of lands adjoining or contiguous to the  
 9 corporate limits of the City of Lincoln pursuant to Neb. Rev. Stat. § 15-106 (Reissue 1997); and

10           WHEREAS, the existing corporate limits of the City of Lincoln as so established and  
 11 fixed are shown upon the map designated as the “Corporate Limits Map” dated July 1, 2003.

12           NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Lincoln,  
 13 Nebraska:

14           Section 1. That the corporate limits of the City of Lincoln in the County of Lancaster in  
 15 the State of Nebraska shall mean the area lying within the corporate limits boundary of the City  
 16 of Lincoln, Nebraska as shown on the “Corporate Limits Map” dated July 1, 2003, attached  
 17 hereto marked as Attachment “A” and incorporated herein by reference. Said boundary is more  
 18 particularly described in Ordinance No. 8730 as amended.

19           Section 2. That the “Corporate Limits Map” dated July 1, 2003 is hereby adopted as

1 the established and fixed boundaries of the corporate limits of the City of Lincoln in the County  
2 of Lancaster in the State of Nebraska.

3 Section 3. That the Director of Public Works and Utilities shall be the official  
4 custodian of the "Corporate Limits Map" and is directed and authorized to amend the "Corporate  
5 Limits Map" as land is annexed into the City of Lincoln, Nebraska to reflect the extension of the  
6 corporate limits of the City of Lincoln, Nebraska.

7 Section 4. Pursuant to Article VII, Section 7 of the City Charter, this ordinance shall  
8 be posted on the official bulletin board of the City in lieu of and in place of newspaper  
9 publication with notice of passage and such posting to be given by publication one time in the  
10 official newspaper by the City Clerk. This ordinance shall take effect and be in force from and  
11 after its passage and publication as herein and in the City Charter provided.
