

ORDINANCE NO. \_\_\_\_\_

1 AN ORDINANCE annexing and including the below described land as part of the  
2 City of Lincoln, Nebraska and amending the Corporate Limits Map attached to and made a part  
3 of Ordinance No. 18208, to reflect the extension of the corporate limits boundary of the City of  
4 Lincoln, Nebraska established and shown thereon.

5 BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

6 Section 1. That the property consisting of approximately 468.49 acres, generally  
7 located at W. Van Dorn Street and S. Folsom Street, and legally described as follows:

18 148, 149, 150, 151, 154, 155, 156, 157, 165, 166, 175, 180, 183,  
19 184, 185, 188 I.T.s, vacated Oyler Street (vacated by City Council  
20 Res. No. A-70331) and vacated W. Calvert Street (vacated by  
21 City Council Res. No. A-77493) all located in Section 3, Township  
22 9 North, Range 6 East of the 6th P.M.; the east 1525' of the  
23 Northwest Quarter of Section 3, Township 9 North, Range 6 East  
24 of the 6th P.M.; and Lots 1-19, Teala's Addition; the east 1525' of  
25 Lot 14, Lot 92, Lot 112, the remaining portions of Lots 113 and  
26 115, Lot 119, the remaining portions of Lots 120 and 121, Lot  
27 122, Lot 123, the remaining portion of Lot 124, Lot 125, Lot 153,  
28 the remaining portion of Lot 155, Lot 157, Lot 162, the remaining  
29 portion of Lot 163, Lot 164, the remaining portion of Lot 165, Lot  
30 179, Lot 180, Lot 182, Lot 210, the remaining portion of Lot 211,  
31 Lot 217, Lot 218, and the remaining portion of Lot 220 I.T's, all  
32 located in the South Half of Section 34, Township 10 North,  
33 Range 6 East of the 6th P.M., Lancaster County, Nebraska,  
34 containing 46,217 square feet or 1.06 acres, more or less;

35 be and it hereby are annexed and included within the corporate limits of the City of Lincoln,  
36 Nebraska and is hereby made a part of the City of Lincoln, Nebraska for all purposes.

1                   Section 2. That the "Corporate Limits Map" attached to and made a part of  
2 Ordinance No. 18208, be and it is hereby amended to extend the corporate limits boundary of  
3 the City of Lincoln, Nebraska, to reflect the above extension of the corporate limits boundary of  
4 the City of Lincoln. Said map amendment is shown on Attachment "A" which is attached hereto  
5 and made a part hereof by reference.

6                   Section 3. Pursuant to Article VII, Section 7 of the City Charter, this ordinance  
7 shall be posted on the official bulletin board of the City in lieu of and in place of newspaper  
8 publication with notice of passage and such posting to be given by publication one time in the  
9 official newspaper by the City Clerk. This ordinance shall take effect and be in force from and  
10 after its passage and publication as herein and in the City Charter provided.
