1. Chris Queen, on behalf of Camp A Way (p.2), has requested this proposed street name change as shown on the attached maps (p.3-4). The small street segment in question was cut off from the rest of Ogden Road to the east by the construction of I-180. Various travel maps continue to show the road as continuous, leading to motorists' confusion.
2. The staff Street Name Committee has reviewed the request and recommends approval.






I am writing to request a name change for the entrance road to Camp A Way Campground, directly off of 1st and Superior Streets. When the emergency services requested that the campground change its address from Rural Route 15 to a standard "grid number", the transposed lines of 2nd St. and Ogden Road were where the mailbox was approximately set.


However, when Interstate 180 was built, it cut Ogden Road in two with only a small length on the west side. Many map makers (including the Alltel phone book) neglect to annotate this. Many travel planning computer programs direct our state's visitors to the eastern Ogden Road only for the traveler to become lost or stuck on a dead-end unpaved road on or near N. 7th Street. After many calls from stranded tourists and letters to computer program writers, online and offline map makers, we have been able to correct a small number of these oversights.

It is our belief that a street name unique to itself, such as **Campers Circle**, will set itself apart and be easy to locate on an atlas or in a street listing guide to help the weary traveler and receive the attention of future map makers.


