1 WHEREAS, St. John's Catholic Church has made application for a permit to
2 conduct a lottery in the City of Lincoln pursuant to Chapter 9.32 of the Lincoln Municipal Code;

4 WHEREAS, said application complies with all of the requirements of Section
5 9.32.030 of the Lincoln Municipal Code.


6 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of
7 Lincoln, Nebraska:

8 That, after public hearing duly had as required by Section 9.32.050 of the Lincoln
9 Municipal Code, the City Council does hereby grant a permit to St. John's Catholic Church to
10 conduct a lottery in the City of Lincoln in accordance with the application filed by Rev. Lyle M.
11 Johnson. The City Clerk is directed to issue a permit upon the payment by the applicant of the
12 required fee, said permit to be valid only for the specific lotteries described in said application
13 and only for a period of one year from the date of approval of this resolution. Said permit shall
14 be subject to all of the conditions and requirements of Chapter 9.32 of the Lincoln Municipal
15 Code.

16 BE IT FURTHER RESOLVED that pursuant to Section 9.32.080 of the Lincoln
17 Municipal Code, a tax of 5% is imposed upon the gross proceeds received from the sale of
18 lottery chances or tickets within the City of Lincoln, which tax shall be due no later than sixty
19 (60) days after the conclusion of each lottery to be conducted hereunder, and if unpaid at that
20 time, shall thereafter be delinquent.
