

APPLICATION FOR HOBBYIST PERMIT INFORMATION SHEET

Revised 8/01/13

- This permit is for motor vehicles only, not trailers, and is for the purpose of vehicles being restored or repaired.
- A VIN number is **REQUIRED** by Lincoln Municipal Code Section 10.42.115.
- The Vehicle(s) must be located at the Applicant's **Residential/Primary** Address.
- **FEE:** \$50.00 per vehicle; **TERM:** 180 days from the date of issuance; **Limit:** 2 vehicles per premises
- Permits may only be renewed 1 time & **must** be renewed **on or before** the expiration date.
- **FOR ALL RULES & REGULATIONS:** please read Lincoln Municipal Code Chapter 10.42 which is available on our website www.lincoln.ne.gov. 1) Click on "Government", 2) under "City of Lincoln", click on "Departments", 3) click on "City Attorney", 4) click on "Lincoln Municipal Code", 5) Click on "Title 10", click on "10.42".
- Any person violating any of the provisions of this Code shall be guilty of a misdemeanor and, upon conviction thereof, such person shall be fined in a sum not to exceed \$500.00, except that each person so convicted shall be fined in a sum of not less than \$100.00 for the first offense, not less than \$200.00 for the second offense, & not less than \$300.00 for the third offense & each offense thereafter. Each day that a violation of any of the provisions of this section continues shall constitute a distinct offense & shall be punishable as such.
