LCHR Staff, Appointees/Volunteers (e.g., Board Commissioners) are not eligible to receive the award.

All nominations must include:

- Nomination Form accurately completed;
- Written Narrative (1000 words or less) describing the nominee's contributions and significant accomplishments;

## **SELECTION CRITERIA**

Nominees will be judged by their outstanding achievements in improving human rights based on **activities implemented, services performed, or programs operated** in the City of Lincoln.

Outstanding achievements in human rights, for the purposes of this award, are understood to result from activities that:

- Demonstrate a commitment to improving cooperation and understanding among people of different racial, ethnic, religious, and other backgrounds; and/or
- Use new and creative measures to fight discrimination, prejudice, and the effects of past discrimination; and/or
- Foster positive intergroup relations by promoting mutual respect, understanding, cultural awareness, and appreciation in business, education, government, health, housing, religion, and other areas of civic endeavor.

A Selection Committee will review the nominations for the Human Rights Award and will determine the award winner through a numerical rating process. The Human Rights Award will be presented at special event in November of this year. The exact date, time and place will be set at a later time.
