Rev. Stat. 13-801, et seq. (Reissue 2007).</p> <p>The member libraries to this Agreement deem it in their mutual interests to coordinate planning and implementation of an open source integrated library system of library resources. The member libraries desire to create a joint administrative entity, known as the Pioneer Consortium, to act on their behalf.
