

ORDINANCE NO. _____

1 AN ORDINANCE amending Chapter 8.38 of the Lincoln Municipal Code (Public
 2 Swimming Pools) by amending Section 8.38.090 relating to permit and variance fees for
 3 swimming pools, and Section 8.38.097 relating to fees for Lincoln Swimming pool operator
 4 certificates and Lincoln pool water quality tester certificates to provide that the City Council
 5 may, by resolution, establish or revise such fees; and repealing Sections 8.38.090 and 8.38.097 of
 6 the Lincoln Municipal Code as hitherto existing.

7 BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

8 Section 1. That Section 8.38.090 of the Lincoln Municipal Code be amended to
 9 read as follows:

10 **8.38.090 Swimming Pool Permit Fees; New; Renewal; Variance.**

11 (a) ~~Swimming Pool:~~

12	_____ New Permit/Plan Review.....	\$465.00
13	_____ Renewal.....	\$365.00
14	_____ Additional Spa.....	\$110.00

15 The City Council may, by resolution, from time to time establish or revise fees for
 16 swimming pools permitted under this chapter.

17 Any new swimming pool permit issued after the thirtieth of September of each calendar
 18 year shall pay 67% of the new permit fee.

19 (b) Renewal Late Fees:

1 (1) A permit holder who fails to renew the permit before it expires, but within 30
2 days of the date of expiration shall pay a late fee of 33% of the annual fee in addition to the
3 annual fee.

4 (2) A permit holder who fails to renew the permit before it expires and fails to
5 renew the permit within 30 days from the date of expiration shall pay a late fee of 67% of the
6 annual fee in addition to the annual fee.

7 (c) Variance Fee. Any person who submits a variance request shall submit an initial
8 variance review fee of ~~\$200.00~~ as the City Council may, by resolution, from time to time
9 establish or revise payable to the City of Lincoln. This shall cover the first two hours of staff
10 review time. Should additional hours be required, each hour thereafter shall be charged at a rate
11 of \$100.00 per hour.

12 (d) All fees for a permit to conduct, operate, and maintain a swimming pool along with
13 any additional fees described above shall be payable annually to the City of Lincoln. All permit
14 fees and variance fees described in this section shall be credited to the Health Fund.

15 Section 2. That Section 8.38.097 of the Lincoln Municipal Code be amended to read
16 as follows:

17 **8.38.097 Lincoln Swimming Pool Operator and Lincoln Pool Water Quality Tester**
18 **Certificates; Fees.**

19 (a) There shall be a fee of ~~\$20.00~~ as the City Council may, by resolution, from time to time
20 establish or revise for each application for a Lincoln Swimming Pool Operator certificate,

21 (b) There shall be a fee of ~~\$20.00~~ as the City Council may, by resolution, from time to time
22 establish or revise for each application for a Lincoln Pool Water Quality Tester certificate.

23 (c) Each certificate shall be valid for two (2) years from the date of issuance.

1 (d) All fees shall be payable to the City of Lincoln and shall be credited to the Health Fund.

2 Section 3. Any and all fees in effect on August 1, 2014, under the sections amended by
3 this ordinance shall remain in effect until such time as the City Council passes a resolution
4 establishing or revising said fees as authorized herein.

5 Section 4. That Sections 8.38.090 and 8.38.097 of the Lincoln Municipal Code as
6 hitherto existing be and the same are hereby repealed.

7 Section 5. That this ordinance shall take effect and be in force from and after passage
8 and publication in one issue of a daily or weekly newspaper of general circulation in the City,
9 according to law.
