

RESOLUTION NO. A-\_\_\_\_\_

1 WHEREAS, the City Council adopted Resolution No. A-87609 on October 14, 2013,  
2 and is authorized under Chapter 28.02 of the Lincoln Municipal Code to establish and revise fees  
3 which the City may charge for National Pollutant Discharge Elimination System (NPDES)  
4 stormwater permit compliance inspections; and

5 WHEREAS, the Health Director has re-evaluated the estimated costs and available  
6 resources to administer, operate, and enforce Lincoln Municipal Code Chapter 28.02, Illicit  
7 Discharges, and has determined that certain revisions are appropriate; and

8 WHEREAS, the Lincoln-Lancaster County Board of Health has reviewed the  
9 proposed fees and recommends their adoption; and

10 WHEREAS, the proposed fees are before the City Council for its consideration and  
11 approval.

12 NOW, THEREFORE, BE IT RESOLVED by the City Council of Lincoln, Nebraska:

13 Commencing on the effective date of this resolution, the schedule of costs for NPDES  
14 stormwater permit compliance inspection fees shall be as follows:
