

ORDINANCE NO. _____

1 AN ORDINANCE annexing and including the below described land as part of the
2 City of Lincoln, Nebraska and amending the Corporate Limits Map attached to and made a part
3 of Ordinance No. 18208, to reflect the extension of the corporate limits boundary of the City of
4 Lincoln, Nebraska established and shown thereon.

5 BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

6 Section 1. That the land legally described as follows:

7 Lot 95, located in the Southwest Quarter of Section 14, Township
8 9 North, Range 6 East of the 6th P.M., Lots 15 and 16, located in
9 the Southeast Quarter of Section 15, Township 9 North, Range 6
10 East of the 6th P.M., and Lot 47, located in the Northwest Quarter
11 of Section 23, Township 9 North, Range 6 East of the 6th P.M.,
12 Lincoln, Lancaster County, Nebraska, and the adjacent Highway
13 77 right-of-way;

14 be and they hereby are annexed and included within the corporate limits of the City of Lincoln,
15 Nebraska and are hereby made a part of the City of Lincoln, Nebraska for all purposes.

16 Section 2. That the "Corporate Limits Map" attached to and made a part of
17 Ordinance No. 18208, be and it is hereby amended to reflect the above extension of the
18 corporate limits boundary of the City of Lincoln. Said map amendment is shown on Attachment
19 "A" which is attached hereto and made a part hereof by reference.

20 Section 3. This ordinance shall be published, within fifteen days after the
21 passage hereof, in one issue of a daily or weekly newspaper of general circulation in the City, or
22 posted on the official bulletin board of the City, located on the wall across from the City Clerk's
23 office at 555 S. 10th Street, in lieu and in place of the foregoing newspaper publication with
24 notice of passage and such posting to be given by publication one time in the official newspaper
25 by the City Clerk. This ordinance shall take effect and be in force from and after its passage
26 and publication or after its posting and notice of such posting given by publication as herein and
27 in the City Charter provided.

1 Section 4. That, pursuant to the Lincoln City Charter Article IV, Section 2a; Neb.
2 Rev. Stat. § 15-247 (Reissue 2012); and Neb. Rev. Stat. § 32-553 et seq. (Reissue 2016), the
3 land annexed above shall be assigned to City Council District #3.

4 Section 5. That the City Clerk is directed to return a certified copy of this
5 Ordinance to the Director of the Planning Department. The Planning Director is directed to
6 transmit the Ordinance and list of property owners included within the area annexed to the
7 Lancaster County Election Commission.
