Quote 1:

But more importantly, the assertion that a novel coronavirus called SARS-CoV-2 "has impacted and continues to dramatically impact" our community has never been proven. Lopez has NOT been able to provide one shred of evidence that SARS-CoV-2 even exists. The tests being used to detect the alleged novel virus are experimental. That means they are untrustworthy. The inventor of the PCR test said it wasn't designed to be a diagnostic tool.

As for the nature of this "impact," keep reading.

Quote 2:

WHEREAS, Pursuant to NEB. REV. STAT. § 71-1630(4)(d)(iii), the Health Director is authorized to investigate the existence of any contagious or infectious disease and adopt measures to arrest the progress of the disease; and..

Response 2:

There is no evidence that Lopez conducted, either on her own, or by proxy, any local independent investigation into the local existence of a novel contagious or infectious disease called COVID-19. She simply followed the herd. She simply relied upon authorities with conflicting interests. And that's exactly what Baird is paying her to do. That Lopez doesn't have the critical thinking skillset to conduct or manage such an investigation is beside the point.

Quote 3:

WHEREAS, Pursuant to Lincoln Municipal Code § 8.18.140 and Lancaster County Resolution No. R-07-0035, the Health Director may order the closure of, or restrict access to, any business, office, healthcare facility, school, or government agency or department for the purpose of controlling the spread of disease or for any activity related to controlling the spread of disease, and the Health Director may adopt any other control measures which are consistent with applicable guidelines of a public sector partner, emergency management agency, and any other applicable laws and regulations; and,

Response 3:

Lopez has now been issuing unjustified city- and county-wide restrictions for over a year. She has ordered the closure of businesses where there was no evidence of infectious disease in that business. She has restricted business capacity when there was no evidence of infectious disease within that business. She effectively declared the entire county a deadly infectious disease zone, again, without evidence. The "flu" is alleged to be an infectious disease that kills people as well, but we have never shut down businesses over it.

Quote 4:

2. Exposure to COVID-19 presents a risk of death or serious long-term disabilities; the exposure is wide-spread and poses a significant risk of harm (including death) to people in the general population; there is a particular subset of the population that is more vulnerable to the threat and thus at increased risk; and the threat is from a novel infectious disease.

Response 4:

Vague terms and assertions. "Risk" and "significant risk" are both meaningless. What is the "particular subset of the population that is more vulnerable to the [alleged] threat and thus at increased risk," and *how* was that "subset" determined? By inherent implication, there must be a subset that is less vulnerable, and/or not vulnerable at all? What are those subsets??

Why weren't the restrictions focused on the "vulnerable" and "more vulnerable" subsets only??

Quote 5:

 Directed Health Measures ("DHM") exist to effectively prevent, limit, and slow the spread of COVID-19 amongst the citizens of Lincoln and Lancaster County and implementation will continue to curtail unnecessary in-person interaction, which is the main means of transmission of COVID-19.
The continued enforcement of DHM is necessary due to the threat posed to members of the public if people gather in large numbers, in close proximity to each other, and in enclosed spaces, thereby increasing the danger to public health.

Response 5:

When and where was it ever proven that simple "proximity" causes and constitutes transmission of a disease called COVID-19? When and where was the ambient air ever tested and proven to contain a deadly pathogen called SARS-CoV-2? Pray tell.

This is truly fairy tail stuff. When Harvard Medical School and Public Health Service doctors had to concede, in a 1919 JAMA article, that they couldn't demonstrate contagiousness of the "Spanish Flu," I'm not going to buy a SARS-CoV-2 and COVID-19 narrative without seeing the actual science for myself. Quote 6:

Quote 7:

8. Dr. Rochelle Walensky, Director of the CDC squarely recommends routine masking to combat the spread of COVID-19; Additionally, the Lancaster County Medical Society Board has concluded the wearing of face coverings by every individual while in public is one of the best methods to slow and stop the spread of COVID-19.

9. The American Academy of Pediatrics has determined education is fundamental to child and adolescent development and well-being and strongly advocates that all policy considerations for the school year should start with a goal of having students physically present in school, and to be able to open schools safely, it is vitally important that communities take all necessary measures to limit the spread of COVID-19.

Response 7:

Quote 8:

11. Notwithstanding the current COVID-19 emergency hospital capacity, as defined by both available

inpatient beds and adequate staffing, within Lincoln and Lancaster County remains finite.

Response 8:

No one has a right to a hospital bed. And no one has a right to restrict the liberty of others under the guise of protecting hospital capacity. Hospitalizations increase every "flu" and pneumonia season. Lopez is being a tyrannical nanny.

Quote 9:

12. 13. Three different COVID-19 Variants of Concern have been confirmed in Lancaster County, Nebraska.

Response 9:

Instead of constantly telling us why the worthless green arrows are not utilized at major intersections in Lincoln, they should drive to work with me for a week in La Vista and observe what it looks like in a municipality that actually does a great job moving traffic and giving commuters plenty of green arrow time in turn lanes. Something in the city traffic department needs to be addressed.
