




Attention Council Members,

I just wanted to take this opportunity to provide a little background information in advance of the council meeting on Monday the 29th. I am serving as the president of the The Bridges HOA and we **strongly opposed to the proposed access conditions** for the Osage Hill Farm Addition. There is much more detail in the attached documents for those that are interested, but we do not believe the residents in our neighborhood should be held financially responsible for maintaining the access to a new development. Access to Osage Hill Farm Addition needs to be provided through **publicly owned/maintained** access. Our streets are privately owned and privately maintained. We are spending money each year on street maintenance and have taken several proactive steps to manage/mitigate the stress on our pavements.

Our concerns and proposed solution outlined in the letter to the Planning Commission were not acknowledged at the meeting (which is not required) nor were does it seem they were considered in the amended change. Thus, we have appealed the decision and will be testifying on Monday accordingly. Our planned testimony is attached for your review. Our proposed solution of **maintaining the temporary access until a publicly owned/maintained access is made available** would seem to be a win/win/win for all parties. We have spoken with the developer for Osage Hill Farm Addition (Mike & Ann copied on this email) and understand they would be supportive of this solution and the access control desired long term by the City/County would be achieved when this area becomes more urbanized and part of the city.

I will not be able to attend the Council meeting on the 29th, but one of our neighbors will be there to testify on our behalf. Please reply all to let us know if there are any questions in advance of the meeting.

I am a resident of the *The Bridges* neighborhood and am here testifying behalf of our neighborhood of nearly 70 families. Our HOA president has been the point of contact through this process but is unable to be present this evening.

On July 18th, several of our neighbors and board members attended a "neighborhood meeting" with Mike Eckert of CDG who was representing the developer of the Osage Hill Farm Addition, where we learned about the proposed development and expressed our concerns (including the proposed temporary access from SW 27th). For those unfamiliar, the proposed Osage Hill development includes a temporary access for construction and then removes the temporary access to SW 27th when alternative access is provided, which as platted would be a connection to the west from our neighborhood or a connection from to the south from a future development.

On July 25th (2 days prior to the Planning Commission hearing) our neighborhood HOA President submitted a letter to the Planning Commission outlining our concerns regarding the access for the new development. The letter was sent in advance because he could not attend the meeting in person (as stated in the letter). We stated our primary concerns were maintenance costs associated with the increased traffic. Recall our streets are privately owned and maintained. Each year our residents are contributing money for panel replacements, joint sealing, and other routine maintenance costs. To help limit those expenses, we are limiting the heavy loads by requiring all residents use the same trash collector at a negotiated rate and we also restrict truck traffic from entering from SW 27th Street. Our letter on 7/25 stated that we "<u>strongly oppose</u>" the development based on the access being proposed and we included a proposed solution to "maintain their direct access to SW 27th Street until the City annexes and takes over maintenance of these developments."

On July 27th at the Planning Commission hearing, there was no mention of any opposition nor acknowledgement that our letter had been received.

As such, we have filed the appeal and are requesting reconsideration.

Note #9 in the proposed CUP states the following:

9. DIRECT VEHICULAR ACCESS TO S.W. 27TH STREET IS HEREBY RELINQUISHED EXCEPT FOR THE EXISTING DRIVEWAY ACCESS POINT THAT SHALL SERVE AS THE INTERIM 30' PUBLIC ACCESS FOR THE COMMUNITY UNIT PLAN, WHEN AN ALTERNATIVE PERMANENT ACCESS ROUTE IS ACCESSIBLE THE DEVELOPER SHALL RELINQUISH THE TEMPORARY ACCESS CONNECTION.

Amended Condition during Planning Commission:

IF THE CONDITIONS OF NOTE #9 ARE SATISFIED, A TEMPORARY HEAVY CONSTRUCTION ENTRANCE MAY BE MAINTAINED AT THE SW 27TH STREET TEMPORARY ACCESS POINT UNTIL SUCH POINT THAT OCCUPANCY PERMITS ARE OBTAINED FOR ALL SEVEN LOTS.

We are requesting to revise the conditions above to provide temporary access until a <u>publicly</u> <u>owned/maintained</u> permanent access is provided (which as planned would be from a future development to the south). We believe this proposed change is in the best interest of both developments and still provides for the desirable access control which is critical when the area becomes further developed and urbanized.

Thanks for hearing our concerns this evening. We hope you also see that you find our proposed solution to be not only a reasonable compromise, but rather a win/win/win.

Dear Mr. Cary and Planning Commission Members,

I am currently serving as the HOA president of The Bridges neighborhood and am writing this letter on behalf of our approximately 65 families. Three of our board members and a few neighbors attended the meeting on July 18, 2022, at Christ Place Church. At the meeting, we were pleased to learn the developer intends to build homes that are similar in value to our neighborhood with similar protective covenants, but we also have a couple concerns.

Our primary concerns are with regards to public road access and sanitary sewer.

Public Road Access – We understood from the meeting that the new roads within this development will be public (maintained by the County) and that proposed access to SW 27th Street would be "temporary" and removed once alternative access is provided (ie. through developments to the west or south).

- 1. Please confirm the understanding above is correct.
- 2. Recall The Bridges neighborhood has private streets that are being maintained (snow removal, panel replacement, joint sealing, etc.) by the HOA. As a neighborhood, we have already taken proactive measures to minimize the distress on the pavement from heavy trucks:
 - a. We have negotiated a consolidated trash collection contract to minimize the number of garbage trucks entering our neighborhood.
 - b. Large trucks are prohibited from entering the neighborhood from SW 27th Street (across our wooden bridge and through the roundabout) and required to utilize at SW 31st and W. Denton Rd.
- 3. Will the County be driving their maintenance equipment through our neighborhood to get to these new public streets?
- 4. The additional traffic through our neighborhood to the Osage Hill Farm Addition will obviously add more stress to our pavements and result in additional maintenance costs. Who will be responsible for these additional costs?

We are strongly opposed to additional traffic (especially the heavy trucks) through our neighborhood on our private streets and request the Osage Hill Farm Addition maintain their direct access to SW 27th Street until the City annexes and takes over maintenance of these developments.


Sanitary Sewer – We understand based on the CUP and discussion at the July 18th meeting, the new development will have its own sanitary system. Given the proximity to our sanitary system, consideration should be given to combining the two systems. I understand this would require analysis to confirm capacity, etc. but this would create an opportunity for cost savings to the developer and eventually to the City with a single point connection. Combining the two systems would also create a need for a consolidated HOA that could also address concerns above regarding public road access and create a more cohesive neighborhood.

Thanks for your consideration of our concerns noted above. I will not be able to attend the meeting on Wednesday at 1:00 but look forward to your response to our questions and suggestions. Please email or call with any questions. anthonydirks1@gmail.com or 402-429-5578.
