I am writing you this email in opposition of the Lincoln Bold building being proposed to be built at the corner of 9th and P street. I want the Lincoln skyline to grow, I want people living and working in the Historic Haymarket.

For so many reasons this is wrong for the Historic Haymarket. I will outline some of them below:

1. **Parking**- This is the number one complaint about the Haymarket currently. The proposal is to build the tallest building in Lincoln without adding a single parking space. More than that they are taking parking spaces from local garages for their tenants. When the project is complete, we will have less parking than we do today. Hausmann Construction estimated between 150-200 workers during the height of the project taking up parking. This leaves very little for my customers. They will also be hooding parking meters and blocking alleyway entrance to the Haymarket garage.

2. **Traffic**- 9th street is what I consider to be the entry way to Lincoln. Entry from Omaha, Western Nebraska or the airport comes through 9th street. You pass the Salt Dogs stadium, Memorial Stadium and Pinnacle Bank Arena. What a cool entry! The projections are to throttle this entryway. Memorial Stadium is the third largest city in Nebraska on football Saturdays. The newest coaching change renews excitement in our football program. Throttling this entryway will create such a headache for businesses, patrons and fans! Kiss the sell-out streak goodbye.


3. **Economic Hardship** on local businesses. Steve Glenn in our first meeting was trying to relate to small business owners. He told us that he owned a hardware store where new construction happened. He experienced a 17% drop in revenue during construction... for a hardware store. What do you think a bar/restaurant/hotel would experience? Significantly more, in my opinion. I am confident that we would survive this situation, but Covid decimated our business, and we are just starting to become healthy again. I am worried that another 2-3 years of revenue disruption would be extremely harmful to our business and surrounding businesses like ours. Even if we survive it, many would not. We understand materials and cranes need to be located somewhere. The footprint of the building is very small AFTER construction is finished.

4. This clearly doesn't fit **Historic Haymarket**. I love the idea of a new shiny building in Lincoln

but somehow this quarter of the block is carved out of Historic Haymarket. I think the building would stand out like a sore thumb and the renderings are cool, but this building does not belong with the surrounding area.

5. **Inconvenience**- Refuse services and Deliveries would be extremely inconvenienced. They are now backing into the alley or pushing deliveries up the hill for 2 blocks. This is not a small thing to consider for our partners that help make this business run.

My name is Jordan Gish. I work in the Haymarket District in Downtown Lincoln, and I am writing you this email in opposition of the Lincoln Bold building being proposed to be built at the corner of 9th and P street. I want the Lincoln skyline to grow, I want people living and working in the Historic Haymarket, but I think the effect on surrounding business is not being considered at the level it should be.

For so many reasons this is wrong for the Historic Haymarket:

1. **Parking**- This is the number one complaint about the Haymarket currently. The proposal is to build the tallest building in Lincoln without adding a single parking space. More than that they are taking parking spaces from local garages for their tenants. When the project is complete, we will have less parking than we do today. In my one-on-one meeting with Brett Wasko (Project Control) and Mark Lureen (Hausmann Construction) they estimated between 150-200 workers during the height of the project taking up parking. This leaves very little for my customers. They will also be hooding parking meters and blocking alleyway entrance to the Haymarket garage.

2. **Traffic**- 9th street is what I consider to be the entry way to Lincoln. Entry from Omaha, Western Nebraska or the airport comes through 9th street. You pass the Salt Dogs stadium, Memorial Stadium and Pinnacle Bank Arena. What a cool entry! The projections are to throttle this entryway. Memorial Stadium is the third largest city in Nebraska on football Saturdays. The newest coaching change renews excitement in our football program. 4. This clearly doesn't fit **Historic Haymarket**. The renderings I have seen make this building even less appealing. A giant skinny metal building does not fit with the rest of the surrounding buildings and ultimately I think this building belongs in a different location

5. **Inconvenience**- Refuse services and Deliveries would be extremely inconvenienced. With so much of the space surrounding the building I work in being used for this project, it will be really tough for delivery trucks to park near us. They are also proposing we have to walk 2 blocks to our trash refuse. Hauling all the trash from 2 businesses on a busy day (example: Husker Game Day) is an extreme inconvenience. These trash bins will also just be on the sidewalk in open air which I think is another bad look for this area of the city.

Please consider that this project has not created solutions for these problems leading up to the start date!

Dear City Council Members,

Hello. My name is Samantha Gross. I was born and raised here in Lincoln and continue to live, work, and worship here as an adult. I've invested a lot of myself into the city of Lincoln and, in return, Lincoln has been good to me. I've received a good education, both as a youth through Lincoln Public Schools and as an adult at UNL. I've worked at well-known Lincoln entities and I've mingled with some of the more prominent and engaged citizens of the city.

I'm writing to you today and am telling you this because I would like to voice my concern for the

planned development on the corner of 9th and P streets. It is my understanding that a developer is proposing to build the tallest building in Lincoln at that location for the advanced cost of \$23 million. As a "Millennial", I am all for growth for our city and advancing in ways that make us stand out. Big buildings are exciting and flashy, but is this something that Lincoln really needs right now?

Our city and many locally owned small businesses are still recovering from the COVID pandemic. The downtown Lincoln and Haymarket areas in particular are composed mostly of those locally owned small businesses and it is projected that the construction of this building will greatly impact those businesses negatively. Parking and traffic flow are already issues in this area and to have obstructions from two to three years' worth of construction will be a nightmare. This city is still "small" enough that many citizens will be angered by the disruptions this construction will cause. Especially think of home football game days and how busy that area is and how this project will impact the experience of our city on those days. Perhaps this is the time to address making downtown Lincoln a more "friendly" place for citizens and visitors through more parking, better traffic control, and setting the foundation for successful developments in the future.

I look around our city and see so many blighted areas and areas where businesses have disappeared, and empty buildings stand in their place. We should be focusing on utilizing these spaces and filling them before we start building new and upwards. Let us channel our resources towards what we have before we start new projects. As a lifelong Lincolnite, I would be so much happier seeing existing structures and spaces being utilized than I would having "skyscrapers" built. What would the benefits of this project really be? Do they outweigh the cost and negative impact it will have on what we already have?

The city I knew as a child no longer exists. In its place I see progress, but I also see history disappearing and cheap modern buildings replacing sound beautiful historical ones. This city used to take pride in its history and the locally owned establishments that existed for generations. Now, those businesses can't afford to keep up with the cost of development and are dying, only to be replaced by chains that last a year or two. If I am going to continue to live, work, and worship here and invest myself and my money into this city, I would much rather we take care of our roots and support the livelihoods of the small local businesses above allowing developers to come in and take over.

I am writing in opposition to the Lincoln Bold Project. While expansion is great for Lincoln, this is in the wrong area.

Football and Pinnacle Bank Arena congest traffic. Incoming traffic is blocked creating a hardship for those local businesses in the haymarket and the railyard. Event parking is high making it cost prohibitive for a family to go enjoy dinner in the Haymarket/Railyard. We've created a situation where small businesses suffer.

Parking is being chipped away. 100 spots reserved for this hotel, or that business. We cannot continue to pack more people into a small urban footprint.

The current garages will not be able to handle this new project. The 2-3 years for street closures, workers taking up parking, etc... then the residents who will need parking. Not to mention the projected convention center. We have a landlocked area between 1-80, the railroad, and the University. We cannot continue to cram more into this small footprint.

This project is irresponsible and a vanity project. New builds in the Haymarket/Railyard should be required to provide enough parking for the living/working units contained within.

Please vote no. There are better areas in which to build this project.

My name is Amanda Martinson and I'm one of the owners of Crescent Moon Coffee located in the Haymarket. I am writing to you today in opposition of the proposed Lincoln Bold project at the corner of 9th and P.

I have worked and lived in the Haymarket for almost 16 years. I fully support the need for growth, housing, and opportunities in our gorgeous historic district, but I feel that this is not the right location for this project.

As a business owner I am just now starting to see business return to pre-covid times. If it were not for the numerous government grants and loans we received we would not still be in business. I'm extremely worried that 2-3 years of construction on this project, which will severely limit access to my business, could be detrimental.

I'm also concerned that this project doesn't include any additional parking spaces for residents and guests of the building. My customers and employees, who already struggle to find parking in the Haymarket, will unfortunately have an even harder time trying to park if this project is approved the way it stands.

I also lived in the Hardy Building for thirteen years, from 2007-2020. The Hardy and Grainger buildings were, and to a certain extent still are, the only affordable housing available in the Haymarket and downtown. We do not need more luxury condos or pricey apartments, we need affordable housing that provides access to a broader range of Lincolnites—not just the very wealthy or students.

I urge you to vote no on this project.
