WHEREAS, Neb. Rev. Stat. § 23-1114 provides that the salaries of all deputies in the offices of the elected officers of the county shall be fixed by the county board at such times as necessity may require;

WHEREAS, Neb. Rev. Stat. § 23-1114.09 provides that the salary of one full-time deputy of the various county offices shall not be less than sixty-five percent of the county officer's salary; and

WHEREAS, the Board of County Commissioners of the County of Lancaster, Nebraska, desires to fix the salaries for elected officers' chief deputies for the 2022 calendar year at the amounts set forth in Attachment "A" to this Resolution, which Attachment is attached hereto and incorporated herein by this reference;

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of the County of Lancaster, Nebraska, as follows:


- 1) The salaries for elected officials' chief deputies for the 2022 calendar year shall be fixed at the amounts provided in Attachment "A".


