

## SPECIAL WASTE TYPES and REGULATED QUANTITIES

### Group 1: Waste that may contain Free Liquids

<b>1</b>	Cooking oil and grease	<b>1 gal/mo or 1 lb/load or more</b>
<b>2</b>	Cooking grease trap waste	<b>any quantity</b>
<b>3</b>	Mud or sand sumps or trap waste	<b>any quantity</b>
<b>4</b>	Septic tank waste	<b>any quantity</b>
<b>5</b>	Chemicals and waste from portable or chemical toilets	<b>any quantity</b>

**The above wastes may be disposed of at the Theresa Street Wastewater Treatment Plant under a free Special Waste Permit if the waste is hauled by a Licensed Liquid Waste Hauler; do not pay for a Special Waste Permit through the Lincoln Lancaster County Health Department. If the waste is disposed at any other location, a Special Waste Permit must be obtained.**

<b>6</b>	Sewage or other organic residues or sludges	<b>any quantity</b>
<b>7</b>	Sludges containing a liquid concentration of 80% or more by weight or material producing free liquids in a Standard Paint Filter Test.	<b>any quantity</b>

### Group 2: Petroleum Based Waste

<b>8</b>	Petroleum type grease trap waste	<b>any quantity</b>
<b>9</b>	Sludges from petroleum tanks	<b>any quantity</b>
<b>10</b>	(a)Used oil filters	<b>less than 220 lbs/month</b>
		<b>over 220 lbs/month</b>
	(b)Petroleum contaminated soil and granular absorbents	<b>220 lb/month or more</b>
	(c)Petroleum contaminated refuse or other materials except oil filters, soil and granular absorbents (i.e shop towels, rags)	<b>less than 220 lbs/month</b>
		<b>over 220 lbs/month</b>
<b>11</b>	Petroleum contaminated water.	<b>55 gallons/mo or more</b>
<b>12</b>	Oil, lubricants, hydraulic fluids, fuels, and other petroleum products used for heating/energy	<b>any quantity</b>

### Group 3: Empty Containers

<b>13</b>	Pressureized containers or containers that may explode upon crushing (i.e propane tanks and cylinders)	<b>No Permit Required must report on inventory</b>
<b>14</b>	Containers over five gallons in size	<b>No Permit Required</b>
<b>15</b>	Empty containers labeled "DANGER" or which once contained hazardous material.	<b>No Permit Required</b>
<b>16</b>	Fuel tanks	<b>No Permit Required</b>

## SPECIAL WASTE TYPES and REGULATED QUANTITIES

<b>Group 4: Solvents, Absorbents, Filters and Residues</b>		
<b>17</b>	Solvents, degreasers, strippers, thinners, and related products.	any quantity
<b>18</b>	Refuse containing solvents, degreasers, strippers, or thinners (i.e filters, shop rags, absorbents or soils)	<b>any quantity</b>
<b>19</b>	Lime or other inorganic residues or sludges	<b>25 gal/mo or 43 lbs/mo or more</b>
<b>20</b>	Paint dry waste, filters, and paint contaminated material	<b>43 lbs/mo or more</b>
<b>21</b>	Fly ash	<b>43 lbs/mo or more</b>
<b>22</b>	Bottom ash	<b>43 lbs/mo or more</b>
<b>Group 5: Hazardous or Toxic Chemicals or Products</b>		
<b>23</b>	Antifreeze or treatment chemicals for boilers, heat exchangers, cooling towers, and similar uses	<b>5 gallon/day or more</b>
<b>24</b>	Chemicals labeled WARNING for toxics or pesticides	<b>1 lb/load or more</b>
<b>25</b>	Pharmaceutical products	<b>5 gal/mo or 43 lbs/mo or more</b>
<b>26</b>	Adhesives, sealants, coatings or catalysts	<b>5 gal/mo or 43 lbs/mo or more</b>
<b>27</b>	Material containing 25% and 100% of maximum concentration of any Toxic Characteristic Leaching Procedure (TCLP) listed chemicals or >0.3 mg/l of nickel	<b>5 gal/mo or 43 lbs/mo or more</b>
<b>28</b>	Hazardous or potentially hazardous waste or chemicals labeled "DANGER"	<b>any quantity</b>
<b>Group 6: Miscellaneous</b>		
<b>29</b>	Treated or untreated infectious waste from hospitals	<b>any quantity</b>
<b>30</b>	Treated or untreated infectious waste from other than hospitals	<b>any quantity</b>
<b>31</b>	Waste containing or likely to contain PCB	<b>any quantity</b>
<b>32</b>	Waste containing asbestos from other than NESHAP or NDOH	<b>any quantity</b>
<b>33</b>	Material other than asbestos that could create a health hazard if airborne	<b>any quantity</b>
<b>34</b>	Wood that has been treated with hazardous or toxic chemicals	<b>43 lbs or more</b>
<b>35</b>	Any other solid waste which, because of it physical, chemical or biological characteristics, requires special handling, treatment or disposal methodologies in order to protect public health, safety, and the environment	<b>any quantity</b>
