S. 40TH STREET REHABILITATION PROJECT

Gertie Avenue to Clifford Drive

PROJECT OVERVIEW

The S. 40th Street Rehabilitation Project will widen S. 40th Street from Gertie to Locust to a three-lane street to accommodate a two-way center turn lane and will also resurface the entire street from Gertie to Clifford with new asphalt. Pedestrian curb ramps will be reconstructed to meet federal and local standards. Due to the widening, trees and other vegetation between the existing curb and sidewalk will be removed as part of the project. Additional work will include pavement markings and priority sidewalk repairs.

CONSTRUCTION SCHEDULE

Tree removal began Monday, March 16, 2020. This work requires several days of daytime closures from approximately 8:30 a.m. to 3 p.m. During these temporary closures, through traffic will need to find an alternate route.

Roadway construction is expected to begin Monday, March 30, 2020. Full closure is anticipated with local access maintained whenever possible and access for emergency vehicles maintained at all times.

The S. 40th Street Rehabilitation Project is scheduled to be substantially complete in August 2020. Please note all dates and timeframes are subject to change due to weather impacts or other unforeseen delays.

ACCESS DURING CONSTRUCTION

S. 40th Street from Gertie Avenue to Clifford Drive will be closed to through traffic for the duration of construction. Access to individual properties will be maintained.

The traveling public is encourage to find alternative routes and to use the Waze app for assistance to plan travel in the area.

The City of Lincoln is investing in streets to ensure a better tomorrow. **Lincoln On The Move** is the result of the city's commitment to doing more to preserve and maintain our streets through the quarter-cent sales tax approved by voters in April 2019.

In fall 2019, the 14-person citizen panel known as the Advisory Committee on Transportation (ACT) hosted a series of open houses and conducted an online survey to gather input from the public on street work to be funded by the quarter-cent sales tax. Using this public input, the ACT provided the City of Lincoln a list of priority projects to be designed or constructed in 2020. **This project was prioritized for 2020 construction.**
