- 3. General LOTM Program Updates
  - a. Revenues
    - The current fiscal year collections continue to trend above projections. FY23/24 LOTM projection is \$15.7 million. Through April 2024, collections for the current fiscal year exceed projections by almost \$1.5 million.
    - ii. The LOTM funding is split between Existing Streets (73.5%), Growth (25.0%), and the Joint Project at N. 33rd & Cornhusker (1.5%).
