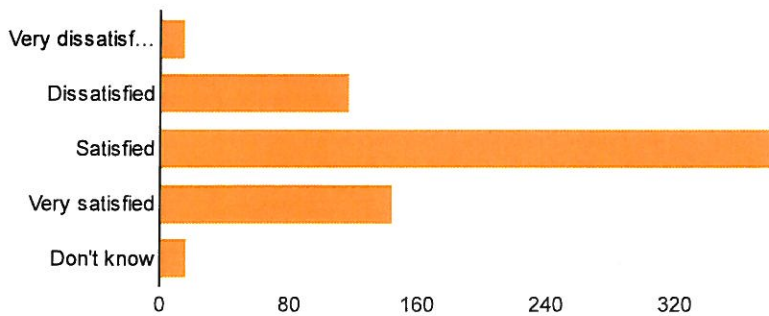

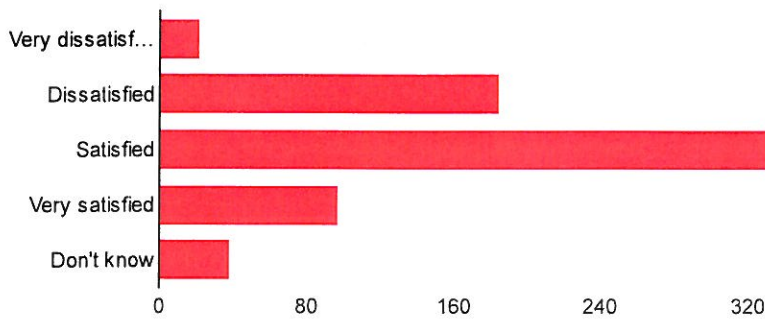

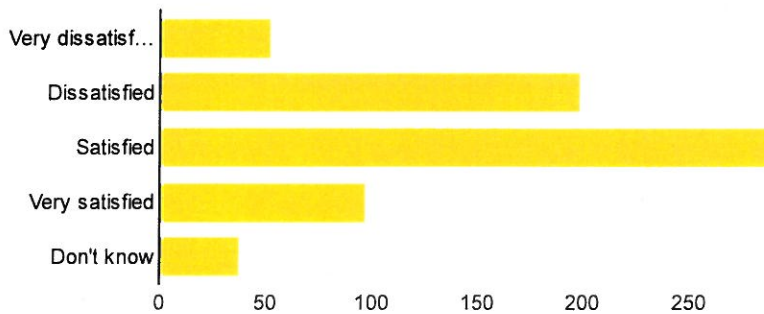

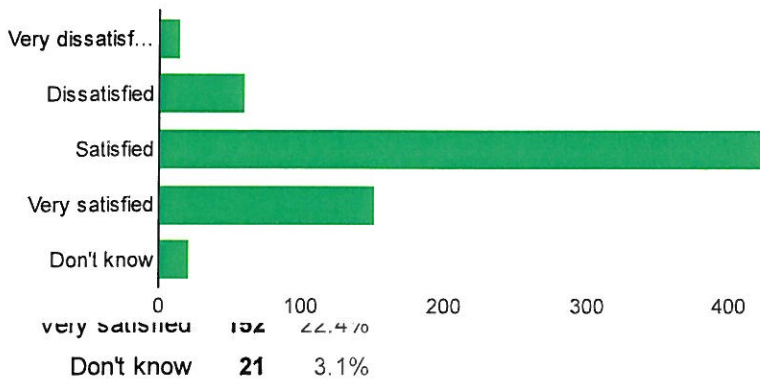

**Condition of bridges [3b. How satisfied are you with each of the following conditions in Wilderness Park?]**

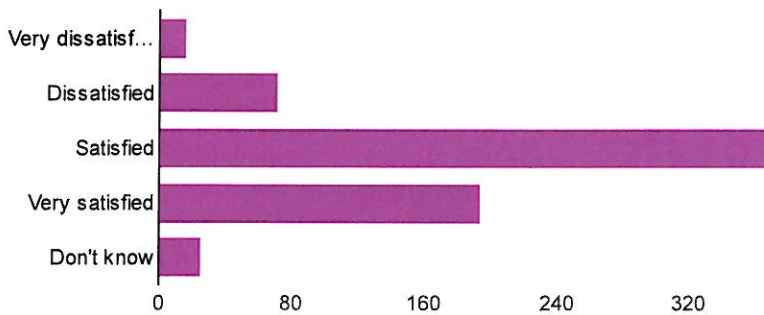

**Entrance upkeep [3b. How satisfied are you with each of the following conditions in Wilderness Park?]**

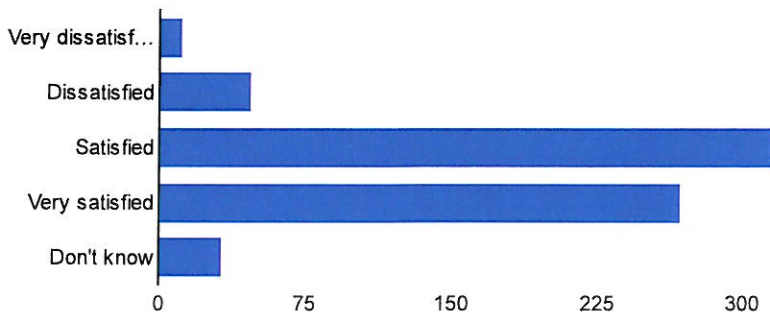

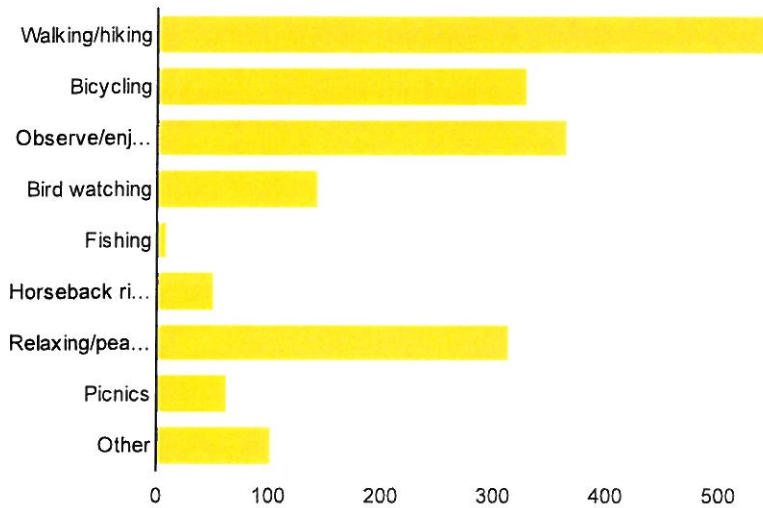

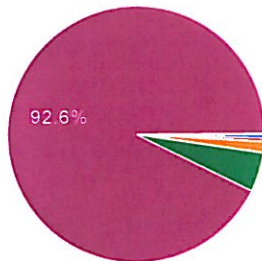

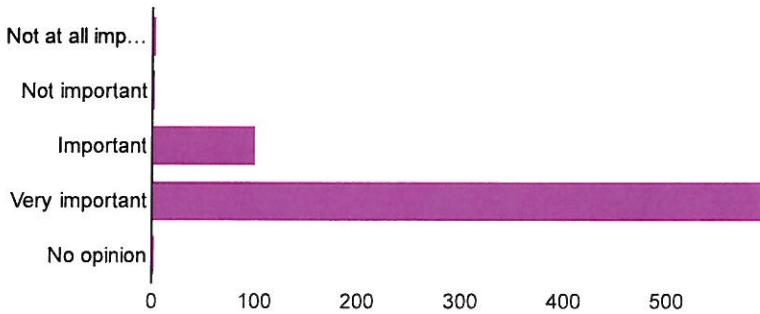

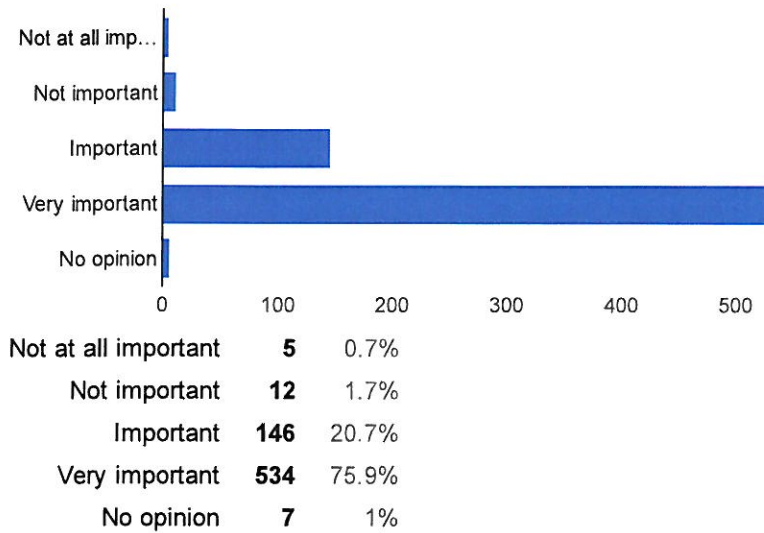
**A place to experience nature [5. How important do you think it is for Lincoln and Lancaster County to have a park like Wilderness Park to provide each of the following?]**



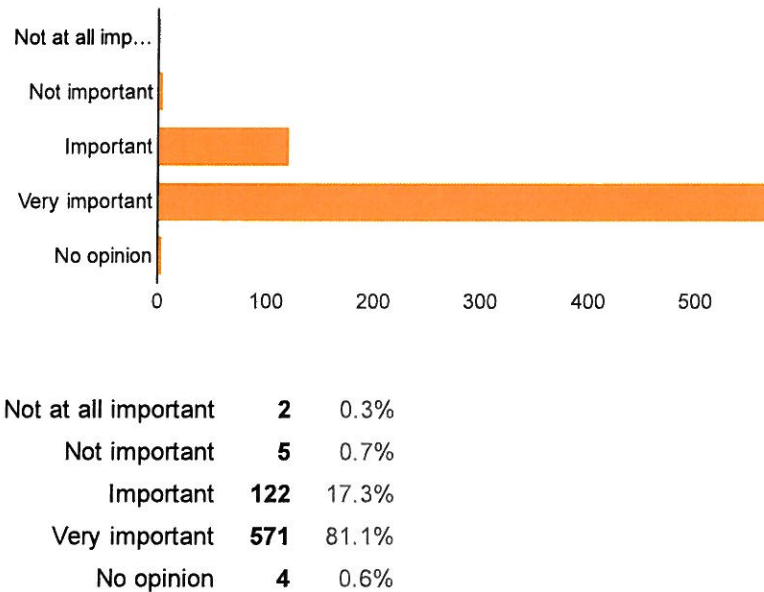

**Nature study - a place to learn about nature [5. How important do you think it is for Lincoln and Lancaster County to have a park like Wilderness Park to provide each of the following?]**

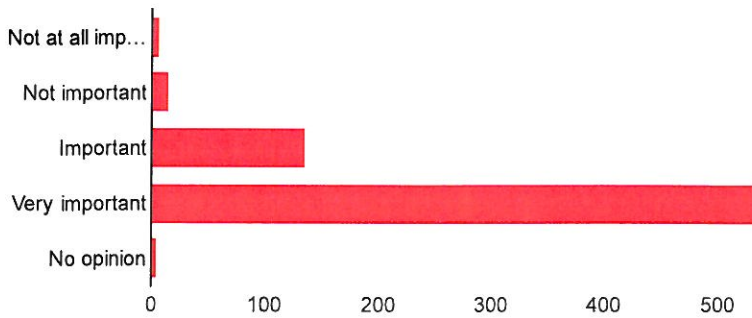




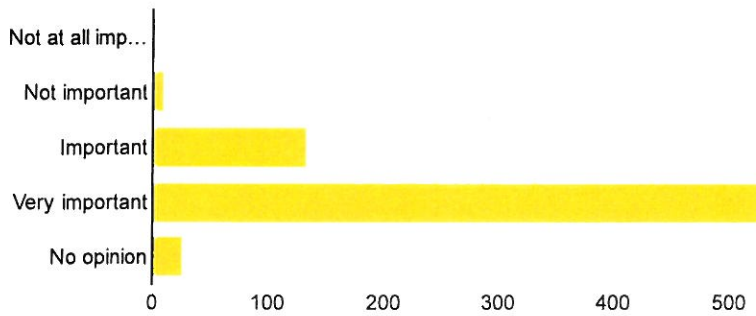

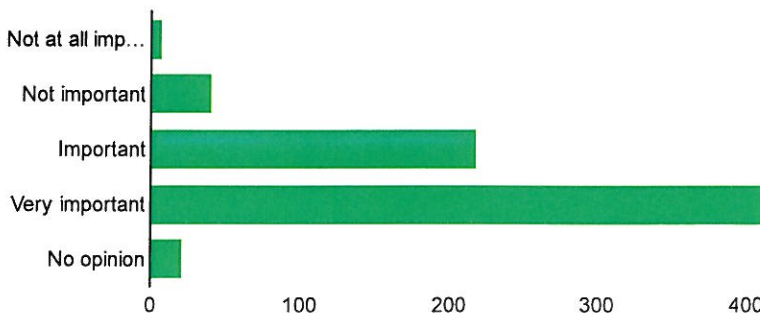

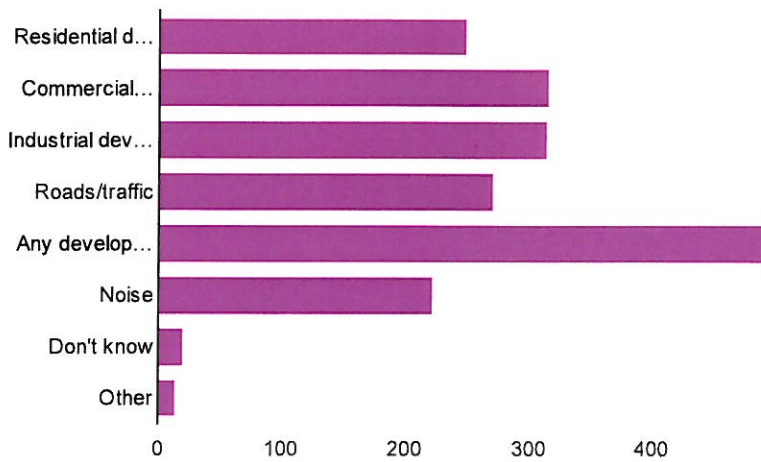

### 6. What type of land use or development do you think would most affect the park?



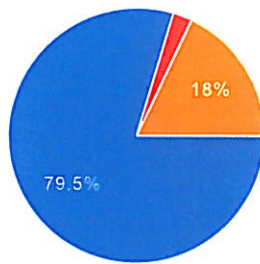

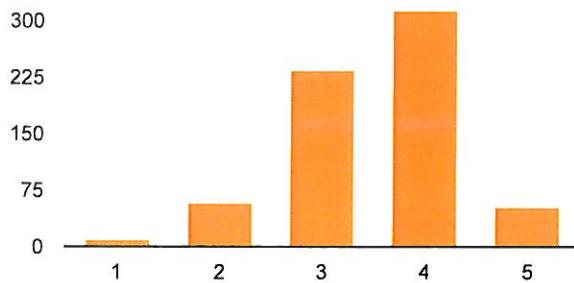

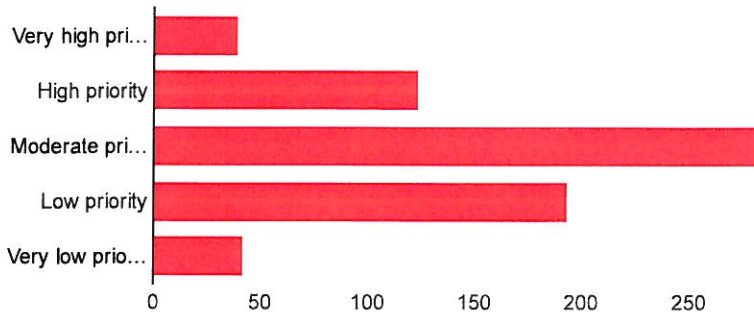

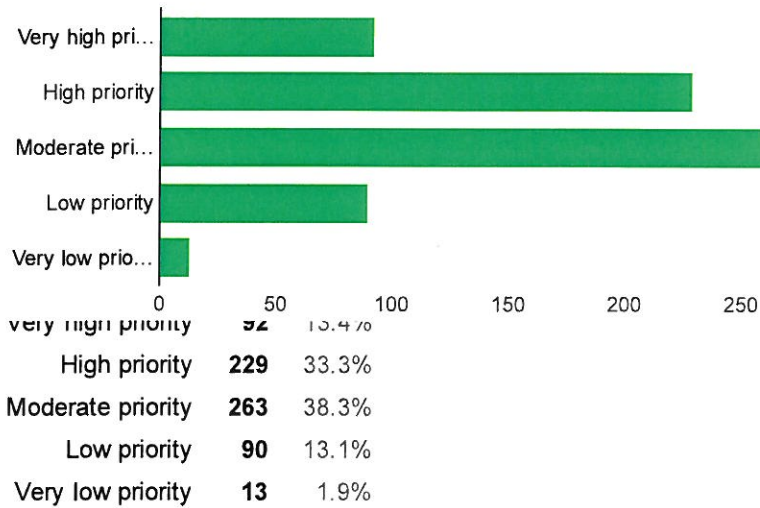

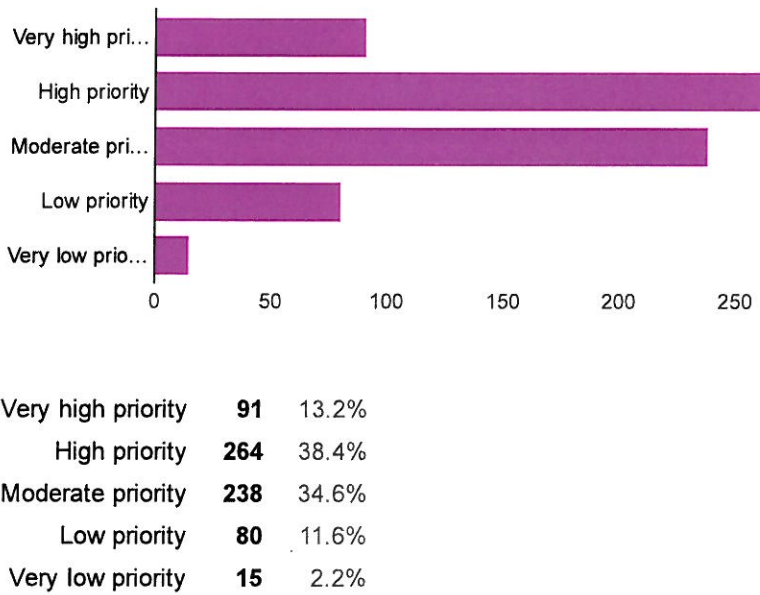

**Trail surface [Please indicate the priority of each of the following maintenance activities.]**



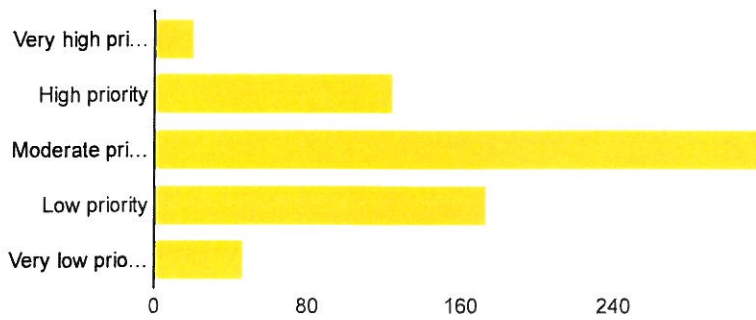

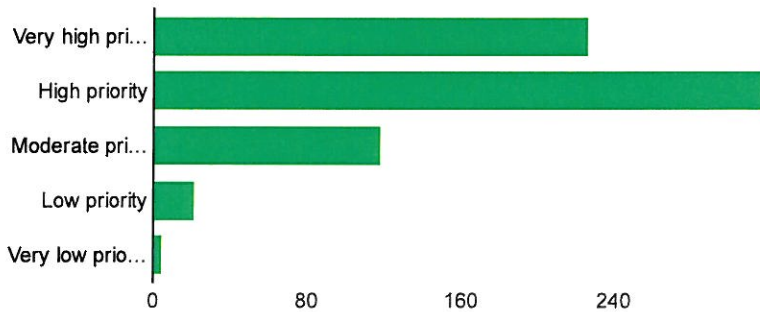

The creek crossing south of Warlick is very treacherous at times. The Nebraska Horse Trails Committee would like to place concrete pallets that we have available as a base for this crossing. The floods will not carry these away and they would provide a nice base for hikers, bikers and equestrian riders who cross the creek. Also, further south the wood swing bridge is not safe for equestrian use. I'm not sure it can handle the weight of a horse and rider.

The horse trailer bridge is unsafe and needs to be replaced or the trail rerouted.

I have much concern regarding the safety of the swinging wooden bridge between 14th Street and Old Cheney. It needs replaced.

Thank you for the well maintained horse trails, would love to have more!

I believe trail maintenance and involvement with the horse community (such as the Nebraska Horse Trails Committee) to improve and maintain the trails are of the upmost priority. I believe getting the horse community involved could be a valuable asset in improving and maintaining the park.

The wooden suspension bridge is in serious need of attention. It has been patched many times but now erosion of the bank is affecting its support and safety.

The days of calling one trail a biking trail and another a hiker trail should be gone. I travel all over and bike on trails and never have hikers barking at me about getting off their trail.

Wilderness park is wonderful-it just makes me feel so sad that I don't feel safe to be there alone because of "other" activities occurring there. I love the trails but really it isn't safe to be out there alone.

My cycling team wants to host a mountain bike stage race, over the course of one day, in the summer. It would be a great way to showcase the beautiful park. We only need to control access (in stages) for one single day, which I don't feel would be too bad with lots of planning and early dissemination of information to the public. And we would prep the trail to make it perfect.

It's not a very nice part of Lincoln. Help south Lincoln by building a road over or through the park by Yankee Hill Road. You already have cut down trees for power lines. Park is mostly an eye sore.

I would support an access road thru or over Wilderness Park off of 14th st. Pave Yankee Hill or generate a new access Rd. West off 14th.

Need bridge from Densmore Park

Better access to the park via bicycle would be huge! Other than bike path along Van Dorn, accessing Wilderness by bike requires riding on Pioneers, Old Cheney, or 14th st. Paved shoulders on any of these would greatly improve park access.

I would like there to be more Xoom areas in wilderness to ride my mountain bike like a pump track and some berms along the trail

it would be nice to have signs that say "please don't use if muddy" or "please don't use the trails if they are soft". maybe a hashtag #thinkifyousink. at each of the trailheads.

I live in Beatrice but I am a member of Friends of Wilderness Park because of the advocacy efforts of the group to support Wilderness Park. I am appreciative of Lincoln's efforts to create and maintain minimal-maintenance public parks. Thank you for exercising the political will to keep Lincoln beautiful.

We need to keep it "wild" and as natural as possible.

Some of the outlying areas of the park need vegetative control like poison ivy flowing over on bike trail

Would love to see a burn in the park as well as addressing invasive species.

My family of four loved hiking in Wilderness Park, it is one of the few places in Lincoln that makes you feel like you have escaped the city and are immersed in nature. Over the last couple years we've only been able to make it a very little ways in before we've had to head back to the car because the trails were flooded. This leaves two very sad kiddos who were very excited to be out exploring nature. Would love to see it restored and taken care of.

Wilderness is my favorite trail riding spot. Tho its hard to venture through the park as thouroly as bikers and hikers can since there are bridges that i would be terrified to walk across alone that i can't even cross with my horse. Fun to explore but don't like trailering just to get past a ravine. Also trail etiquette is lacking severly. It gets old when bikers on the horse only trails get angry about us being there when we stay clear of the bike n hike only trails

A lot of overgrown vegetation and weeds there are opportunities to clear some ares for grass and picnic areas and replace weeds with tall grass prairie that would enhance wildlife and aesthetics and human park use.

I love to run through the park with my dog, however the signage isn't clear where I can run and not encounter mountain bikers. I encourage the activity, however I have had many bad encounters with fast riders upon curves, and have on occasion scared or injured my dog as a result. I tend to avoid the park during times in which I know these riders use the trails, as they can tend to be reckless or unapologetic of their dominance in the space.

Wilderness park is a natural drainage basin that needs to be left to do its job, controlling waters and a nature preserve, changing or altering it would be a mistake, leave it alone and let nature take its course in the park. Society wants to control every inch of land. Even the National Park System knows that some land need to be set aside to remain wilderness and not developed by people. Wilderness Park is our Natural Nature Preserve.

For safety reasons trails should be open to all users. A loop is much safer than an out and back and would prevent dangerous head-on collisions.

Make all trails accessible to both bicycles and hikers so that the trail can be made safer by allowing a traffic loop rather than out and back which can cause head on collisions.

Some of the deep ruts can be dangerous , as I have wrecked a few times when my tires get caught in them.

There is one bridge on the west side middle of the park that is closed with what looks like permanent signs telling us so. There is no other good access point to the southwest trail there without it.

It is a flood control device and should not. Cost the taxpayers anymore than to control flooding

There needs to be designated directional flow for hikers and bikers that is opposite each other.

This allows for each party to see each other well in advance. Also, bikers shouldn't be allowed to travel opposite direction, as head on collisions happen all the time out there and could be avoidable easily if traffic only flowed in a single direction

To be able to walk around and see nature in a fairly untainted way helped me gain perspective when I needed it. I would hate any of that to be taken away for future generations to experience. Because once it is gone, it would be so much harder to replace. I would like to thank the city and county for having the insight to have such a place in Lincoln.

The only drawback that I find using Wilderness Park is the lack of good signage. As a horse rider I have encountered bicyclists getting in my way and spooking horses, as they seem to think they own the park and trails. I would like to see bicycles banned from the park altogether but that will never happen, so I have quit riding horses through the park. Only my opinion, for what is worth.

Wilderness park will never be peaceful, clean, or what you want it to be (considering it's called wilderness park). It's worth protecting because some people don't know what else is out there, but I'll go to a WMA any day. If I wanted to see people and trash I'd walk my dog down the street. At Wilderness Park, I run into ten people practically before I leave the parking lot. Disappointing.

It would be great if the police or park staff could crack down on homeless camp sites in the park. A greater presence of staff in Wilderness Park would help alleviate safety concerns for park users. Lastly, there is a great deal of historical information about the park that could be communicated to park users and the public, whether by developing online publications/resources, or by providing historical markers in the park. would like to help do what i can

Seriously dudes, we've got an amazing thing going here, don't screw it up.

Wilderness park is a treasure. I'm there every week spring through fall. It's one of the only places in Lincoln where I can feel solitude. It's easy to get lost, so I would like more signage where the trail splits, and maps at the parking lot entrances, but this is low priority since all trails eventually lead out of the park, and really, it's hard to get lost for long.

We spend lots of time in wilderness park and want very much for the name to carry on as its description. We are lucky to have such a gem!

In regard to very high importance of "fallen limbs" I associate my response with both safety issues of limbs being on the ground (trip hazard) and being indicative of storm event or age that may have impacted other nearby trees. Just offering an explanation of why I see this of utmost importance.

There is literally nowhere else this close to lincoln with single track dirt trails for recreation. It's a great network of trails and my favorite spot to run in lincoln.

Please give the community opportunities to volunteer and interact with the park. This might be done by collaborations between the City and local non-profits that have an interest in the park (e.g. Friends of Wilderness Park, Wachiska, etc.).

Since flood a year ago there's still tons of garbage mainly plastic pots from the nearby greenhouse place. THEY should be responsible for not cleaning up their garbage

Love the park, one of the best in Nebraska. Please don't over maintain the park! It leaves it feeling "un-wild."

These projects require having enough people to do the job, you can't keep piling work on to people and reducing the number of employees to actually do the work. Most people working in the park's system actually care deeply about the parks and want to do a good job but find it impossible to do the work well if they are asked to do more and more work than they can complete. I have no relation with people in these positions, they are my own observations. Thank you for offering the survey, hopefully it will help to solve the difficult questions you are asking.

The parks and trails here in Lincoln are very important to making Lincoln an attractive city to live in. It is great to have a place nearby to go and enjoy the outdoors and to bike or hike.

I don't feel safe in the park. There are too many perverts hanging out there and there's no police presence. I don't use it much because of that.

Watching this park for the condition prior to and after flooding ...trees still in waterway..waiting for FEMA funding or something? Other 300 K cities take care of this without the needs of surveys. The concerns of forestry are sorely lacking in this park and this observation is from a degreed forester with other community forestry backgrounds in two other states. Time Lincoln do the same with the resources it's has or put low time offenders to work in these parks....Plenty of other cities use jail labor for these types of operations "to save money." I understand there are competing interests for resources, but Lincoln has not demonstrated a need to me for additional tax revenues when Wilderness Park has been sloppy appearing in riverine areas with timber downfall and whatnot and should demonstrate the basics before coming to the public for any additional money being slapped onto homeowners.

That doesn't mean I want it to look like a residential park with concrete walkways and playground equipment. Not at all. Keeping the wild in wilderness park is very important to me. However, efforts to maintain the park for sustainability and to preserve and protect the wildlife and ecosystem takes a lot of time and effort. Wilderness Park is truly a treasure for Lincoln and Lancaster County! We have always been big hikers and this is really the only place close by that makes it feel like you are actually out hiking, instead of just strolling in a city park. (But it is very difficult to walk on the trails in the muddy season.) But, my biggest concern is making sure that the bridges are safe and that they are maintained so all of the paths in the park can actually be utilized. The flooding last year was really devastating to the park, and there seemed to be insufficient support of the park by the city to bring it back to shape in an expeditious manner. Obviously tree maintenance must be addressed also to make sure that folks are safe from falling trees. I would be more than willing to help with projects on an ongoing basis, both with financial and with hands-on labor.

To save the park as a whole, should consider an additional East-West roadway as the park should mesh with local requirements. If we balk at additional crossings we risk losing support of the park as a park vice flood control.

As a heavy Wilderness Park (WP) user from 1989 to 2014, I can say bridges are a top concern, and stopping the encroachment of commercial and residential sprawl from entirely surrounding the park. WP needs to continue to educate other users that cyclists are important users of WP, and contribute (and have contributed) thousands of volunteer hours to maintenance and bridge-building. Keep WP open and protected - it is one of the last green spaces of any size within Lincoln.

Hearing possible bike park being planned for old city dump. Very interested in volunteering if that happens!

I'm dismayed that areas that were once predominately grass/prairie have been allowed to become overgrown with scrub trees/cedars over the past two decades. "Wilderness" in Nebraska really means prairie areas, not a tangle of Russian Olives. I'd think that the city could easily partner with groups like the Environmental Trust, Pheasants Forever and Ducks Unlimited to restore old oxbows, do prescribed burns and maintain prairie areas to create valuable habitat. Specifically, areas on the south end of Wilderness Park on either side of 14th St, and some nice (former) fields along Highway 77. There's some very nice, now-dry oxbows on the east side of the road that could become decent fishing spots and habitat for ducks, geese and other waterbirds. By restoring these areas to grasslands, the city might also be able to hay them occasionally to feed buffalo and other animals at Pioneers Park, cutting city expenses and keeping out the invasive trees and shrubs. I'd also suggest that an area on the north end of Wilderness Park, just north of Van Dorn on the west side of the Salt Creek Bridge, be considered for a new dog park. It's got some nice trees and an old field for dogs to run. Some fencing remains and cars could park on the east side of the now-closed bridge on Van Dorn, or along the old Van Dorn Street on the west. An additional benefit would be to keep deer out of the area, which is close to two, four-lane roads, thus reducing collisions. Lincoln needs a dog run in the southwest part of town. This would put that area – which is sort of separate to the rest of Wilderness – to good use.

Important to get a directional bike loop for safety. Complete the South Bridge, South of 14th to connect the far South Section of Wilderness again.

Wilderness Park is a rare treasure for our City and should be preserved, be given bridge funding, and protected from urban encroachment.

I really enjoy the work that is put into the park. Many people donate their own time to help the County maintain the park (i.e. mowing, cutting in cross country ski trail, etc.)

It can be difficult to near impossible to find Wilderness Park if you are unfamiliar with the area. As transplants to Lincoln it was frustrating the first time or two we tried to find the mythical Wilderness Park. More signs on the way and next to the entrances and better online directions might help. Lincoln needs all the natural green spaces with trees it can get.

When/if you start removing dying/dead ash or other species in decline, the wood should be utilized in the highest value, i.e. not all mulch. Benches, picnic tables, possibilites are endless. Drop me a line if you'd like to investigate utilization.

Other bridges that were closed for safety have taken a long time to restore/repair. Hoping for more effective solutions. Flood control is a given, w/incised channel of Salt Creek, but required several months of closure before re-opening, out of necessity, it seems. I appreciate the low-key mowing/brush/tree-limb maintenance of trails, to keep it wild, but hope that safe & sturdy bridge maint. will continue to be a priority. Thanks to workers and crew-leaders who have learned to temper their zeal for power tool trimming and felling, such that returning trail users will not be shocked by the impacts of their work. Any who connect with the place, beyond the paycheck, will soon understand how shared maintenance strategies for both safety and aesthetics can blend for a better trail experience. I feel that my fellow hikers & other users come to seek the quiet beauty and rare discovery that one finds in this natural corridor. It can be a place for individual renewal and healing, but also for the company of fun and challenge, too.
