Report Review for 22-02 – Hoke and Pajnigar were the sub-committee members who facilitated the informal hearing and provided their report. The board accepted and concurred with their findings that no corrective action is required. The proper notification letter will be sent to the complainant informing them of the disposition.

Annual Review of 2022 complaints – In conjunction with CPAB rules and regulations, a review of the previous year's complaints was heard to discern if there was a pattern for the types of concerns being presented. It was determined there was no indication of such.

Fourth Quarter and 2022 Annual LPD Incident Summaries and Case Review

Sgt Dittman and A/C Morrow reported on LPD's 4th Quarter (Oct 1st thru Dec 31st, 2022) IA Case Review, Statistical Summary, Employee Incident Report Summary, and Employee Use of Control Summary. <u>Of note</u>:

- There has been a 36% reduction in the use of force after implementation of BWC's.
- Total number of dispatched calls were down from 121,890 (2021) to 114,913 (2022).
- Total number of traffic citations and warnings were slightly up from 2021 while misdemeanor and felony arrests remained virtually static.
- Total number of investigated complaints/inquires slightly up due to increased internal accountability and review, while citizen complaints were down; 209 (2021) to 176 (2022).
