Mayor Gaylor Baird's Comments (given by Jon Carlson on behalf of the Mayor who was unable to attend):

• COVID is stable – numbers are down. There will be a press conference to announce the availability of the new booster.

- There have been some recent homicides, but violent crime is down. The main crime in the city is auto burglaries.
- Rent and Utility Assistance Program is winding down will be done by the end of the year. The program is only providing assistance for those who have not received previous assistance.

The Lincoln Community Foundation on behalf of its partner funders, along with the University of Nebraska Public Policy Center, will present the most recent findings from the recently published Lincoln Vital Signs. - Data is Broad overview from public sources. Trailing indicators through 2019; does not include pandemic period. Tracking long-term trends
- Community profile population growing, older citizens growing fastest. Newcomers drive the growth. Most are white, but 21% are non-white.
 - Percent of population below poverty threshold. Baseline date of 2008, rose & didn't drop to 2008 level until 2019
 - Three census tracks below poverty level
- Children largest concentration in areas south of downtown
- Economy & Workforce
 - High workforce participation (72%)
 - Low unemployment (4.2%)
 - Cost of living 94% of national average

Education

- o High rates of proficiency compared to rest of Nebraska, but drop from COVID
- o Graduation rates are also higher than rest of Nebraska & national rates
- Free/Reduced public school lunch program enrollees increasing

Health

- Lancaster Co life expectancy it about 80 yrs. Some census tracts are much lower
- Lower deaths due to cancer, heart disease
- Births to teen mothers trending lower, following national trends
- Youth alcohol & cigarette rates are declining
- Youth marijuana use steady, but lower than national

Crime

- Youth Crime rates in drug & property crimes are higher than national rate
- o General crime is lower than national
