To clarify, I think bump stocks are a gimmick, but I also think this ordinance is just one of many that lead to unintended consequences.



Dear members of our Lincoln City Council,

This letter is to explain our appeal of the Lincoln City-Lancaster County Planning Commission's March 3, 2021, approval of Waiver WVR21001. We are unable to attend the City Council's meeting due to the COVID virus, but would like all the council members to know our objections to WVR 21001.

Mr. Euler of Euler Rentals is requesting a waiver of the 3:1 width to depth ratio on his rental property at 3239 South 46<sup>th</sup> St. in order to put in another driveway and build a house in the backyard of the property. In his request he states the request waiver is "minor". But to the people in our neighborhood, this is a <u>major</u> change that would directly affect our homes, property, and privacy. To build a house in the back of the property affects at least a dozen homes and their families. The residents in the rental property at 3239 South 46<sup>th</sup> St. especially would have <u>no privacy</u> to go in their backyard to relax, use their grill, have their children play, etc. They would be in the "front yard" of the house built behind their house!

We have lived in this neighborhood since 1975—46 years. We bought our home because it has a large lot as our neighbors probably did so for the same reason. We all take care of our properties and love this neighborhood. Mr. Euler has been buying properties in our neighborhood over the years. We feel that if he is allowed to build a house in the back of his rental property at 3239 South 46<sup>th</sup> St., he will do this to more in the area—all for more profit rather than for the good of all the families in our neighborhood. This would set a precedent and it is important to stop trying to squeeze a second house anywhere on a property.

We are certain no one on our City Council would approve of building a house in their or their neighbor's backyard and give away their privacy. The house Mr. Euler proposes to build is only about 100 feet from our backyard on Sherman Street. Mr. Euler has implied that he has come into our neighborhood as our saving grace to clean up all the trash filled properties which is simply not true. We love our neighborhood and take care of our properties.

On March 3, 2021, two members of the Lincoln City/Lancaster County Planning Commission voiced concerns and had reservations about Mr. Euler and his Waiver21001 and his plans, but

went ahead anyway and approved the waiver. We strongly feel it should not have been approved and this is why we are making an appeal to our Lincoln City Council.

Other neighbors have their objections on record with the Lincoln City/Lancaster County Planning Commission. We ask that you read these also.

Please consider our objections and those of our neighbors and overturn the approval for Waiver 21001 Resolution PC01746. We want to keep our neighborhood and not have it in control of someone who is in it for a profit rather than thinking of what is good for the people in our area. Please do not let Mr. Euler destroy our neighborhood!

Dear Mayor Gaylor Bairdand Members of City Council,

My name is Dana Friesen and I am a resident of Lincoln. I write this letter to urge you to begin defunding and demilitarizing the Lincoln Police Department. LPD's budget has increased by 14% since the 2017-2018 budget. For the 2019-2020 year, the portion of the general fund spent on LPD was just under 25%. LPD's increased funding is a direct harm to other necessary and more needed services in our city. Other services including parks and recreation, transportation and utilities, and urban development take much less out of the general cost for the city: 9.8%, 1.3%, and 0.5% respectively (Source: 2018-2020 Council Adopted Biennial Operating Budget). LPD is a direct cost to other services this city desperately needs.

As Lincoln residents, we therefore demand that you take immediate action to ensure the following:

- \* Reduce LPD's allocation from the General Fund.
- \* Reallocate those funds into housing, jobs, youth programs, restorative justice, mental health workers, and community development programs to keep the community safe.
- \* Disallow unauthorized overtime by LPD.
- \* Discontinue use of General Fund dollars to pay for settlements due to police murder, misconduct, and negligence.

Lincoln cannot wait any longer for a budget that meets the needs of its residents. The only way to achieve this is to take immediate steps to defund LPD.

# Carbon storage holds promise, senators told

Flood says sequestration facility in state would be win for ethanol, climate

LINCOLN — Nebraska would create a "win-win" for the state's ethanol industry as well as climate change by facilitating the creation of a carbon capture and storage facility, state lawmakers were told Tuesday.

State Sen. Mike Flood of Norfolk said establishing a carbon sequestration facility in Nebraska would provide ethanol plants, coal-fired power plants and manufacturers a place to store their carbon dioxide emissions instead of releasing them into the atmosphere.

For an ethanol plant, storing its carbon would improve the "carbon score" for the corn-based fuel it produces, making it more attractive for sale to California, which seeks fuels produced with low carbon.

"When I can find a win-win (situation), I'm all for it," Flood said.

His proposal, Legislative Bill 650, would set up the legal and regulatory framework for the development of carbon sequestration wells, which would be at

least 2,600 feet deep and store carbon, in an intermediate gas/ liquid state, in underground formations conducive to storage.

Matt Joeckel, the state geologist and director of the Conservation and Survey Division at the University of Nebraska, said prior studies have shown that there are areas of central and western Nebraska that have the right conditions for carbon storage.

Joeckel added that he is aware of a company that is exploring establishing a carbon storage facility at an ethanol plant in the state but emphasized that it's still an emerging technology. There are two dozen such sequestration

facilities worldwide, with one in the U.S., at Decatur, Illinois.

"It is vital that comprehensive geologic and engineering studies are done first," Joeckel said. "It matters what rock formations you're putting this into, down to the microscopic scale."

Two state senators, John Cavanaugh of Omaha and Eliot Bostar of Lincoln, raised concerns about such a project before LB 650 advanced from first-round debate on a 41-0 vote.

Bostar questioned whether increased seismic activity could be sparked by injecting the carbon

underground, as fracking has done in oil well regions of Oklahoma. Cavanaugh wondered how personal property rights might be impacted.

Flood said he would work to ad-

dress any environmental concerns about carbon sequestration before the bill got to second-round debate. Joeckel, when asked later Tuesday about Bostar's concern, said that carbon sequestration is quite different from fracking for oil, and that the risk would be "vastly" lower.

Flood said he introduced the

bill because it could help rural Nebraska. Venango Sen. Dan Hughes, who represents an area that could be conducive for carbon sequestration, said it presents a tremendous economic opportunity.

The federal Environmental Protection Agency, Flood said, would continue to have primary jurisdic-

tion over carbon sequestration projects under LB 650. Two states, North Dakota and Wyoming, have passed bills to assume primary responsibility of carbon sequestration projects, he said.
