Thank you for reaching out to us about this issue. We want to make sure our right-of-way areas are safe for everyone and minimize the risk of damage to property. Your situation highlighted an opportunity for us to coordinate better with private utilities. We are now creating a process when we receive information such as the information you've provided that we will route to all private utilities to determine the owner responsible. We will then require that the issue be resolved timely and will monitor the resolution. In your case, we have reached out to the utility companies.
