Subject: N.W. 48th Street Redevelopment Area/Blight Designation/Airport Authority Property

Chairman Bowers and Members of the Council:

It was with considerable consternation that, on Friday morning, June 26th, Lincoln Airport officials first learned, by happenstance, that large tracts of property under the custody and control of the Airport Authority were on the cusp of being declared blighted and extremely blighted by the Lincoln City Council. Then, to our further consternation, we learned that an amendment was being demanded by a few individuals, purporting to represent Nine Mile Prairie, to remove the Airport properties from the designation.

The properties in question are two residentially zoned outlots that were the subject of the 2007 Huskerville Agreement between the City, Lincoln Public Schools and the Airport Authority, and a quarter section of land immediately south of Fletcher Avenue.

How does the Airport Authority feel about the inclusion of these properties in the proposed blighting designations? How would we know? We have been provided neither the time nor the background information so as to be able to make an informed decision. How does the Airport Authority feel about deletion of these properties from the proposed blighting designations? Same answer!

There has never been any formal correspondence to any representative of the Authority that the subject properties were going to be included for consideration as "blighted and substandard." Yes, there apparently were public notifications of the proposed action and perhaps we are derelict in not realizing that, from the obscure notices, Airport properties were affected. However, specific notices were sent to a variety of affected groups and associations, including Lancaster County Board of Commissioners, Lincoln Public Schools, Education Service Unite #18, UNL Property Management, Southeast Community College, Lower Platte South Natural Resource District, Lancaster County Assessor, Arnold Heights Neighborhood Association, High Ridge/Cushman Neighborhood Association and Hub Hall Heights. At first

perusal, it would appear that almost every elected body and owner's association affected by this study was formally notified of it <u>except</u> the Lincoln Airport Authority.

Upon learning of this upcoming action, several members of our senior team met to understand the impact of the designation and identify what the Authority's position should be as it relates to the impacted properties. The Airport Authority intends to sell the outlots in the vicinity of Arnold Heights Elementary School, following through on the understandings incorporated into the 2007 Huskerville Agreement. Designation of these areas as blighted and substandard may have potential tax incentives accruing to any future development, and indeed there may be a possible synergistic relationship between the development of blight-designated properties and your new recreation center to the immediate east. Airport officials believe that, regardless of the lack of communication, a blight designation, for some or all of the subject properties, might work in our favor.

However, the proposed amendment to delete the Airport properties wholesale should be dismissed out of hand. No reasons were cited as to why this specific amendment was being proposed. However, we have heard, albeit anecdotally, that the amendment offered due to concerns that such a designation would encourage development on the property in direct conflict to the interests of groups seeking to create an enhanced buffer zone for Nine Mile Prairie. On Friday, we reached out to Dave Wedin, the Director of Nine Mile Prairie. He has assured us that neither he nor the UNL Foundation have raised any concerns regarding the proposed inclusion of Airport Authority properties in the designation of blight. It would appear that this amendment is being proposed on behalf of Nine Mile Prairie by an entity or individuals not authorized to represent either Nine Mile Prairie or the UNL Foundation.

I ask for a postponement of all action on Items 5.c and 5.d, until the Authority has had the ability to fully consider the issue and properly submit its comments and opinions to you and other City planning bodies. At a minimum, we request your rejection of the proposed amendment to delete Airport properties from the designations.

Representatives from the Airport and the Airport's legal counsel are planning to be in attendance at the meeting on Monday.
