Members of the Lincoln City Council,

My name is Eric Reiter and my pronouns are they, them, and theirs. I'm a constituent of Legislative District 26, City Council District 1, and most importantly, the city of Lincoln. I'm reaching out because of concerns I have about the "Fairness Ordinance", or whatever the title will be of the legislation proposed to outlaw LGBTQ discrimination. I've heard rumors floating around about this amongst many of my colleagues and peers who share many of the same concerns I have, and I feel the responsibility to address them with you all.

My primary concern is our ability to win this issue at the ballot. It's no secret that the Nebraska Family Alliance and Nebraska Catholic Conference are licking their chops waiting to seize the opportunity to pour their resources into an opposition campaign to any number of social issues, including LGBTQ+ rights. I've seen the Warner chamber at the state capitol filled to the brim with anti-LGBTQ+ folks hungry to see their homophobia and transphobia block any kind of meaningful progress. That goes the same for the folks who have bombarded school board meetings across the state, and even effectively scared the State Board of Education into taking no action at all despite having a majority of the board supporting the comprehensive sex education standards. These folks are empowered and organized and waiting for an opportunity to claim victory over a marginalized group at the ballot box. I think if we are going to do this, we need a pragmatic and organized coalition to carry out a thoughtful and well-executed field strategy.

Another concern is the lack of inclusion of the transgender and non-binary communities in this conversation. I have not once heard of or been invited to any sort of conversation with city council seeking to hear the perspectives of the trans/nonbinary community. I'm certain that if there had been, there would be a much more concise understanding that trans and nonbinary people will become targets by the opposition and be most vulnerable to harm. After the successful Yes on 3 campaign for trans rights in Massachusetts, it was found that there were nearly 5 times as many calls into The Trevor Project (a nonprofit providing suicide prevention and other services to LGBTQ+ youth). This was in a considerably more progressive state and with plenty of resources to assure a victory. I am not aware of any resources devoted to developing a proactive infrastructure of support for this community, and can't help but feel that going into this without a plan or assurance of protection is wildly irresponsible.

I'm also troubled at the idea that public accommodations could be axed to make the bill more palatable to voters. I can't explain how frustrating this is, given that public accommodations are where our community needs protection the most. LGBTQ+ employment discrimination is outlawed based on the June 2020 SCOTUS decision in *Bostock v. Clayton County*, and it's been documented that the Nebraska Equal Opportunity Commission will be hearing and processing claims of housing discrimination based on the precedent set in *Bostock*. I completely understand the need to codify at the city level, but to leave out the one place where there is no support otherwise seems counterintuitive and defeats the purpose of the proposed legislation to begin with.

I'm happy to discuss any of these points made with any of you over coffee or a phone call as well. I will be on the front lines to fight no matter what happens, but I would feel much better knowing all of this was taken into consideration beforehand.

## **Lopez let the cat out of the bag**

**"There's a lot more testing going on in Lincoln...if you're not testing, you don't have cases."** -Nurse Pat Lopez, Director of the Lincoln-Lancaster County Health Department (LLCHD), News Conference, September 28, 2021.

Nurse Lopez inadvertently let the cat out of the bag. Without testing, they can't have cases. Without cases, they can't scare the health and life out of people. Fear alone causes illness. It induces stress. Given enough stress, negative biological change occurs. The more people who indulge in the fear, the more illness there is to reinforce the fear.

Nonstop fearmongering is health-damaging, not health-promoting. Baird and Lopez know this. Your first mistake was assuming these people care about you.

Manufactured pandemics are easy to create, given 100+ years of contagion theory programming and a bought-and-paid-for media (by virtue of advertising dollars). Just create a novel contagion narrative. Then a fake test to fuel that narrative with panic. Then new and harmful/deadly medical treatment (and nontreatment) protocols to treat that narrative. Broadcast that narrative day and night, along with videos of people falling over as if they were dying.....and sit back and wait for sick people to start showing up at hospitals, like they have been for decades. Test them with the fake test, and apply the new protocols. It's one big self-fulfilling prophecy.

It was never about a virus. It was about facilitating a global population and financial reset...to implement a new world order. The pandemic is the depopulation arm of Green New Deal/Climate Action activism. It's irregular warfare. It's disinformation warfare. Compared to flying bullets and bombs, it's "clean" (less messy) warfare. But it's warfare nonetheless. People are dying unnecessarily. That was the intent all along, all Orwellian/dystopian rhetoric from "useful idiots" to the contrary. The perps are hiding behind a contagion narrative.

Mayor Baird's pandemic emergency and climate emergency are interwoven.

### **My story.**

From day one of the announcement of a novel contagion, I knew it was a lie.

From day one of the mandates, I knew they had nothing to do with keeping people healthy and everything to do with creating fear, strife, division, dependency and worse.

I made it my mission to expose the lies, and to have fun doing so.

Since June of 2020, my wife and I have traveled high and low and far and wide. Destinations have included FL, TX, CO (x2), SD (x2), WI and MO.

We immersed ourselves in the community everywhere we went. We engaged in lengthy, substantive, face-to-face conversation.

Not once did we wear a mask. Not once did we think to distance ourselves from those we engaged.

We extended our hands, and often our arms, in loving and caring embraces. We thrived on being examples to others that there was nothing to fear in the way of a novel deadly contagion.

We haven't had a sniffle the entire time.

### **Where's the science?**

Between travels, and local social events, I began writing local officials. I wanted to get them on record.

I sent a Public Records Request (Nebraska's version of a FOIA request) to Director Lopez asking for a copy of the science behind her authoritarian mandates. I outlined what the science required.

She pushed my request to the city attorney's office. They replied on her behalf, saying Lopez hadn't issued any authoritarian mandates (excuse me...they were forcing small businesses to close, reduce capacity, wear masks, etc) and redirected me to the CDC. They passed the buck. They hadn't reviewed any science. They were simply following the narrative pushed down by the green new deal globalists.

I sent the same request to Nebraska's chief medical officer, Dr. Anthone. They had no records responsive to my request, and likewise redirected me to the CDC.

For good measure, I refocused on the local health department, this time addressing my letter to Scott Holmes. He's part of management. I asked him to show me where the novel contagion was. He didn't answer. I didn't expect him to. I knew he couldn't answer. The request was an informal one, designed to simply get him on record. His silence speaks volumes.

I had one other interaction with the "health" department. Two lower level employees were busy policing a local small business one day. They were worried the managers might be conducting too much commerce. God knows, you can't let a local small business flourish during a "pandemic." Too much commerce and someone just might die...but only in a small business...not in a big box. At any rate, because I happened upon them, I took the opportunity to briefly interrupt, share my experience, and ask them to explain my good fortune. All they could say was "you're lucky."

Science is about observation and experimentation, and drawing logical conclusions from the same. Science is repeatable. Science isn't about luck, happenstance, belief, naked assertion or expert worship. By saying I was lucky, they were telling me they knew nothing about the science. All they had was a narrative. A story.

**The following is neither science nor proof of a novel contagion**

- 1) A video of people falling over in the streets.
- 2) A micrograph (picture from a microscope) of cells, cell components and other debris.
- 3) A cell culture where cells are dying from being starved and poisoned.
- 4) A computer generated image, and/or genetic sequence, of an alleged novel contagion.
- 5) A computer generated animation of the same, attacking and hijacking cells and replicating.
- 6) The mere observation that people are getting sick. Especially when the symptoms are nothing new. The FDA and CDC are both on record as saying: "No particular set of signs or symptoms can reliably discriminate covid-19 from other respiratory viral illnesses." Obviously, there are other explanations, if the symptoms are basically the same. People are always getting sick, and there are other causes for that sickness. A novel contagion isn't required, and must first be proved, before it can be asserted as the cause. You don't just get to arbitrarily choose your favorite "cause" (a "virus"), just because it fits your agenda.
- 7) The mere observation that people have died and "covid" has been listed as the cause. Cause of death

determinations can be very political. Canadian physicist Denis Rancourt established that quite well, back in June of 2020, with his paper entitled: "All-cause mortality during COVID-19..." There are other explanations for these deaths. A novel deadly contagion isn't required.

8) A sudden rise of premature excess mortality, especially when the footprint for that mortality mirrors all cause mortality (where the older people get, the more likely they are to die). The rise can easily be explained by a sudden change (for the worst) in medical protocols. Lots of people are at the mercy of medical care, due to chronic ("pre-existing") conditions. Many professionals have and are attributing the excess "pandemic" mortality to government malfeasance and medical malpractice...to government and institutional homicide. Quoting (Rancourt): "[the increased mortality represents] ...an accelerated mass homicide of immune-vulnerable individuals, and individuals made more immune-vulnerable, by government and institutional actions, rather than being an epidemiological signature of a novel virus..."

But the absence of chronic/pre-existing conditions prior to a given death isn't a rebuttal to the above paragraph. Those non differentiating symptoms referenced in the FDA quote above, or any symptoms for that matter, can easily be hijacked by a false narrative and a fraudulent test. Just apply new and harmful protocols to the hijacked symptoms and voilà, you have your so-called healthy pandemic victims.

Again, it is easy, given the reverence of the general population for white coats, and the fact that the media is basically owned by big pharma by virtue of their advertising dollars, to turn a pandemic announcement into a self-fulfilling prophecy.

9) The mere observation of cell damage. Lots of things cause cell damage.

10) The mere fact that someone tests "positive." You have to prove that the test identifies the novel contagion and ONLY the novel contagion (after you first prove the novel contagion exists).

#### **What constitutes science in this matter?**

You start with a specific problem, i.e., a specific "effect," for which you desire to find the cause.

This specific problem could be an old problem or a new one. (If it's an old problem with an already existing cause, you must answer the question, Why are we/they looking for a new cause for an old problem that we already have a cause for?)

Either way, the specific problem, the specific effect, has to be well-defined.

The next step is to come up with a hypothesis as to the cause of the specific problem. (This step would be skipped if you are already looking at a potentially new cause for an old problem.)

The next step is to isolate and characterize the hypothesized cause. In other words, you must comprehensively define its distinctive nature and features.

The next step is to conduct experiments to prove the hypothesized cause-and-effect relationship.

Association isn't causation. Correlation isn't causation. Just because two events happen in sequence doesn't prove the former caused the latter. Maggots are associated with manure. Mosquito larvae are associated with stagnant water. Microbes are associated with dead carcasses. Firefighters are



associated with structure fires. Do any of those associations prove that the former caused the latter??

Note: The medical community is well acquainted with the logical fallacy of correlation equals causation. They deny causation all the time when it comes to vaccine injuries, calling it correlation only.

Moving on. At the same time that you are conducting experiments to prove cause-and-effect, you must also run a parallel Control experiment to ensure that the way in which you are conducting the experiment is not, in itself, causing the effect you're looking to blame on your hypothesized cause. If the Control experiment has the same outcome, your hypothesized cause isn't the cause. (Virology utterly fails in this regard.)

To establish a cause-and-effect relationship, the effect must follow the cause every time, barring intervention.

If the effect (the problem) you're looking to find a novel cause for is cell damage, i.e., damage to living tissue, as would be the case with Wuhan ("covid") illness and death, things get complicated very fast.

Not only must the damage be well-defined, it must occur when the cell is in its natural environment (i.e., in the body). The reason should be obvious. The body has natural defenses that protect its cells. You have to make sure your hypothesized cause can get past those defenses, and do so in various groups of people. Starting with the healthiest.

Not all cells are created equal. Cells differ in vibrancy and vitality from one person and one age group to another. What is a threat to one person or group may not be to another.

If the effect doesn't follow the hypothesized cause every time, your hypothesized cause is not strictly a cause. It is only one factor, and a factor that can obviously be mitigated by other factors.

The science above has not been done. And we haven't even addressed the contagious factor.

### **But is it contagious?**

Assuming you've succeeded in proving cell damage causation at this point, you still have to prove your cause to be contagious.

To be contagious, your cause has to be a living organism. It has to be capable of creating and expending energy, of independent movement, of responding to its environment, of rapid self-replication. How else is it going to spread? If it isn't alive, you're done. Your cause isn't even a pathogen, let alone a contagion. It's only a contaminant or a toxicant.

If this question had seriously been raised at the start, as it should have been, the work would have been over in short order. Viruses (what they call viruses) have never been shown to be living organisms. The cell-hijacking narrative about viruses is just a story. It's never been proven.

Just because a doctrine is long-standing doesn't make it true.

But let's just say, for the sake of argument, that your cause IS a living organism. This still doesn't prove

it's contagious. A snake is a living organism, and certain snakes are poisonous, meaning they can cause cell damage, but that doesn't make it contagious. Again, unless your pathogen is capable of rapid self-replication and can easily be transmitted (just exactly how capable and how easily is another question)—and that, against available prophylactics—it can't qualify as a contagion.

The truth is, such contagions only exist in movies. No one has ever proven such an organism exists.

Doctors from Harvard Medical School and the Public Health Service tried back in 1919 to prove the "Spanish Flu" was a function of a deadly contagion, and couldn't. I have the JAMA article on the experiments they conducted, which amounted to directly exposing healthy people to the body fluids of sick people.

No one has proven that Wuhan (aka covid) illness and death are the function of a novel contagion.

No cause-and-effect relationship has been established either by way of a novel toxicant OR a novel contagion.

### **What's really causing illness and premature death?**

The fact is, we don't need a novel cause. We have plenty of "cause" right under our noses, with all the harmful chemicals/toxicants/EMFs in our air, water, beverages, food, skincare products, drugs, vaccines, etc. Wuhan has some of the worst air pollution in the world. That's enough to cause pneumonia.

Sure, there are certain insects and parasites that we need to protect ourselves from, just like there are alligators, but these aren't contagious. And people groups have been managing them quite naturally for eons.

The cause of first world illness is a toxic, nutrient-deficient, sedentary lifestyle and thought-life. We literally make ourselves sick over time by what, and how much, we ingest, absorb, inject, imbibe and inhale, by how we think and by whether we move or not. Health requires muscular activity and movement. Otherwise metabolic waste from cellular metabolism accumulates in the tissues.

And once again, just because microbes are present in unhealthy tissue doesn't prove they caused the unhealthy tissue. Their job is to help clean it up. Mankind couldn't survive without the work that microbes do.

Acute "illness" only appears to be contagious because lifestyle runs in the family, and among friends. Our bodies also react to seasonal changes. When people say they "caught" something, the truth is, their lifestyle finally caught up with them. The body will only take so much before it needs to relieve and detoxify itself. People have been programmed by big pharma to view these acute detoxification symptoms as "sickness," caused by some virus. But they are really only the body cleaning, repairing and curing itself. The last thing you want to do is suppress them with drugs. That only leads to chronic, degenerative disease.

Henry Bieler, MD, doctor to the stars, said it well way back in the 1960's:

The theory that illness is the result of toxemia \*inside\* the body is not a pleasant one for the patient; Pasteur's theory that disease is caused by organisms from \*outside\* the body is easier

to accept. For then he can pity himself as merely a victim of a ruthless enemy and cry: "Why did this have to happen to me?"

Over and over I explain to patients, "Your pain, misery and illness result from your own dietary mistakes and drugs. You are suffering because you are filled with toxic wastes caused by your diet of poorly selected food filled with artificial flavorings, preservatives, synthetics, over-processed ingredients—too much stimulating food, too few natural vitamins from vegetables and fruits. Even if you selected wholesome, natural foods, they were probably improperly prepared, boiled to death or overheated in oil, then covered with harmful condiments. The normal chemistry of your digestion is upset not only by these toxic wastes but also by harmful drugs, unhealthy living habits that include lack of exercise. So, highly poisonous materials—toxins—which have stagnated in your blood, impair the filters and eliminative organs, chief of which are the kidneys, liver, bowels and skin."

These toxins are the villains—the real cause of disease; they must be eliminated if the body is to be restored to health. Illness, then, as we know it, is nothing more or less than a terrific "attempt on the part of the body to rid itself of morbid matter."

This is the first cornerstone on which I built my house of health.

Big pharma won't tell you this. They won't tell you to look at/change your diet and lifestyle. Healthy people don't serve their bottom line. Virus doctrine does, and it serves it very well. It serves as great cover and a scapegoat for the real cause of illness. It also serves as great cover for subversion by foreign and domestic enemies.

The reason I and many others remain unscathed during this "pandemic," despite living normal lives, is because we know where true health comes from. We know God gave us incredible bodies that give us warning signals well ahead of time, and we know how to listen to those signals and adjust our lifestyles accordingly. I'm absolutely serious when I say I haven't had a sniffle since the "pandemic" started, and well before.

### **Wrap-up**

There is no novel deadly contagion. Baird, Lopez, Anthone, and Rauner are just regurgitating the narrative of their globalist green new deal depopulation overlords. None of them have done their homework. They all get a big fat F.

Robert Rauner is trying to make himself relevant by chasing fragments of genetic material and calling them variations of a contagion. He may have correlation. He may have association. But he's nowhere close to causation.

We the People are not disease vectors. I repeat, God gave us a biological makeup that is self-protecting, self-healing, and performs wonderfully well, IF we give it what it needs, nutritionally speaking, and stay out of its way with our bad habits and bad thinking, both of which are addictive, and, you could even say, contagious. They say laughter is contagious. So are bad habits.

Covid is a cult of Materialism.

What about the asymptomatic transmission doctrine? Given what I've said above, both the symptomatic and asymptomatic transmission doctrines are logical fallacies of the correlation-equals-causation kind. They have never been proven. And, if what I've said above is true, they can't be proven. You have to have a contagion, first. These doctrines are nothing but fearmongering propaganda.

A combination of malnutrition, exposure to environmental pollutants/toxicants, medical malpractice and stress from war were all they needed back in 1919 to explain the so-called Spanish Flu.

A combination of the same, with the addition of stress from tyranny and non-stop fearmongering, are all we need to explain the current so-called covid pandemic.

What they call a virus isn't a living organism. That fact alone throws the idea of a novel contagion out the window.

None of the above is to say that there isn't some new harmful chemical/toxicant/pollutant/contaminant out there being injected into our food, air, water, bodies, etc., such as with the current "vaccines" (which may contain anything) and electro-magnetic fields (EMFs), but none of these are contagions. Parasites aren't contagious, either.

Baird's mandates were never designed to protect people from an alleged novel deadly contagion. They were never designed to help people. To the contrary, and I repeat, they were designed to create fear, division, suffering and loss of livelihood. "Covid" is all politics. Green new deal advocates think the earth is overpopulated. They are trying to depopulate it. There's only one way to do that.

The whistleblowers are everywhere.

Don't fall for the fallacy of appeal to experts. "Experts" are often wrong, for many reasons.

Use common sense. There is nothing new under the sun. Fear God and only God.

I could say a lot more, but I will leave you with this quote, which is a continuation of the one above:

The body's "terrific attempt" to burn up these waste products results in fever. And it is the changes (usually destructive) in the organs being used as avenues of emergency vicarious elimination which constitute the pathology, or conditions and processes of a disease.

Since "emergency vicarious elimination" is probably new to you, let me explain it, for it is another important cornerstone of my treatment in the fight against disease; I will have much to say of it in future chapters.

The liver and the kidneys are important eliminative organs. For the liver, the natural avenue of elimination, of course, is through the bowel; for the kidneys, through the bladder and urethra.

However, when the liver is congested and cannot perform its eliminative function, waste matter (toxins) is thrown into the blood stream. Similarly, when the kidneys are inflamed, toxins are also dammed up in the blood. Toxic blood must discharge its toxins or the person dies, so nature uses vicarious avenues of elimination or substitutes. The lungs, therefore, will take over the task of eliminating some of the wastes that should have gone through the kidneys, or the skin will take over for the liver. It stands to reason that the lungs do not make very good

kidneys. From the irritation caused by the elimination of poison through this “vicarious” channel, we can get bronchitis, pneumonia or tuberculosis, as is determined by the particular chemistry of the poison being eliminated. Thus we can say that the lungs are acting vicariously for the kidneys or are being called into play, under duress, as substitute kidneys. In the same way, if the bile poisons in the blood come out through the skin, we get the various irritations of the skin, resulting in the many skin diseases, or through the mucous membranes (inside skin) as the various catarrhs, or through the skin as boils, carbuncles, acne, etc. Thus, the skin is substituting for the liver, or a vicarious elimination is occurring through the skin.

Following this line of thinking, the name of a disease is based upon a description, macro- and microscopic, of the changes in the organs being used as emergency avenues of elimination. After the cells have been damaged by toxic wastes, it is easy for bacteria, as scavengers, to attack and devour the weakened, injured and dead cells.

Disease, then, as I see it is an unnatural elimination process. In order to speed along or facilitate the natural elimination process of the toxic material and return the patient to health, I found necessary either (1) complete abstention from food (fasting for a few days or longer) or (2) abstention from those foods which created the patient’s toxemia.

Ladies and Gentlemen,

I live on South 27th near Southpointe Mall. Every night around 10 or 11 we have young "adults" leaving the Mall or coming out of the neighborhood and besides racing, many of them have the large bellows type of "muffler" on their little cars which are Popping and Howling literally drowning out even the Television in the living room. Many of them make the pictures on our walls vibrate and shake. Since we have various noise ordinances in Lincoln covering excessively loud exhaust systems it would be nice if they were enforced and perhaps put a ban on this type of exhaust system. When you consider that "Mufflers" are by definition supposed to suppress sound from engines and not enhance and make it louder these "Mufflers" definitely do not fit that definition. We have the noise ordinances to make and maintain the quality of life in our capital city, yet we do not enforce them. I wrote the Mayor's office about this, but did not even receive an acknowledgement that it was received.

Adequate exhaust system: No person shall operate a motor vehicle or motorcycle equipped with an exhaust system that emits excessive or unusual noise. A motor vehicle or motorcycle owner/operator may request from the Lincoln-Lancaster County Department of Health that a stationary noise level test be made to determine whether the exhaust system emits excessive or unusual noise. Said request must be made within ten days from the date the operator is cited for operating a motor vehicle or motorcycle equipped with an exhaust system that emits excessive or unusual noise. The exhaust system will be considered adequate if the sound level limits set forth in Table 3 are not exceeded. The penalty for violation of this subpart is set forth in Section 8.24.170(c).
