RE: Notice of final action by Planning Commission: June 14, 2023

Please be advised that on June 14, 2023, the Lincoln City-Lancaster County Planning Commission adopted the following resolutions:

Resolution PC-01862, approving SPECIAL PERMIT 08042A, for the Terrell Garage to allow for the reconstruction and expansion of a nonconforming garage with waivers to the side and rear yard setbacks, on property legally described as the S 1/2 of Lot 12, Block 1, Tuttle's Subdivision, located in the SW 1/4 of Section 19-10-7, Lincoln, Lancaster County, Nebraska, generally located at N. 30th and Q Streets; and

Resolution PC-01863, approving SPECIAL PERMIT 23021, to allow for a CUP (Community Unit Plan) and a Neighborhood Support Services Building, on property legally described as Lots 7-9 and Lots 12-16, and the adjacent vacated North-South alley, and the East half of Lots 10-11, Block 32, Mills 2nd Addition to University Place; and Lots 5-6, and the adjacent East-West alley, Block 32, Mills 2nd Addition to University Place, located in the SE 1/4 of Section 17-10-7, Lincoln, Lancaster County, Nebraska, generally located at the NW corner of North 52nd and Holdrege Streets.

The Planning Commission action on these applications is final, unless appealed to the City Council by filing a notice of appeal with the Planning Department within 14 days of the action by the Planning Commission.

I am a near lifelong Lincoln resident and live in the Hawley Hamlet.

1). Neighbors squabbles do break out, but we seem to have an issue of a neighbor that is acting in a retaliatory fashion against other members of the neighborhood that she thinks have wronged her, given the work that our neighborhood has tried to do to create urban Gardens, bee and butterfly preserves, as well as areas for equipment to be kept, we may have gotten ahead of ourselves and the city codes.
