Dear Council Members:

I am pleased to see that Lincoln is moving forward with supporting Sober House Living. My professional experiences have included working at The Bridge and The Independence Center, so I know the importance of housing post-residential treatment. There are a few concerns I continue to have; mainly that there is no required oversight. I havent read the entire new ordinance, but I hope there are also stipulations for clients not sleeping in basements without escape windows etc.

The main purpose for my email is to continue to encourage the Council to reconsider the ordinance that makes it unlawful for more than three unrelated individuals to live together. Although there are numerous new housing projects in the works, few units will be affordable for Lincoln citizens making minimum wage or a few dollars more.

I have never been a "but what about...." type of person. But if it's safe for 10 people in recovery to live in a single house, it is safe for six un-related individuals to live in the same house. With the shortage of rentals in the \$400-\$500 a month range, it makes sense to me to encourage "collaborative" living amongst working low-wage earners so their housing needs too can be met.

Whether it is safe or appropriate for six to 10 individuals to live together in one house should not be determined by the presence of disabilities. I appreciate that there are legal implications involved in allowing those in recovery to live together. But I think it is reasonable to revise the current ordinance limiting no more than three unrelated individuals....to allowing up to six unrelated individuals to live together. Let's ensure ALL citizens have the opportunity to live with a reasonable amount of others for financial and social well-being.

Hello-

My name is Caspian Nespor, and I am a disabled rider who uses a walker and thus relies on the paratransit service.

For the past month or so, there have been massive and unpredictable delays in service, sometimes spanning hours from the original estimated pick-up time. The drivers have frequently told me that they have been unable to get a van that is in road-safe condition during this time.

With the population aging nationally, and with the aftereffects of COVID leaving one in six patients with long-term damage to the cardiopulmonary, immune, and neurological systems, the city has an increase in its disabled population that the paratransit system cannot keep up with at its fleet's current size and condition.

I would have brought this matter up at an open-mic session rather than an e-mail, but given this selfsame issue with transportation, I am afraid I would not make it to a 3pm meeting on time to do so. Therefore I strongly urge the City to increase its fleet of paratransit vans and ensure that the ones it currently has are all in proper condition.

Dear Council Members,

My name is Eric Willman and I am writing to express my concern for our young people here in Lincoln. With very few spaces of belonging with solid programing and people in our community who would care for our youth, I fear for what happens to our future community leaders or lack of if they continue to be underserved. As a passionate advocate for education and youth development I am writing you to express my strong support and urge the City Council to consider establishing the community center proposed by Family Service Lincoln at 52nd and Holdrege. Currently I serve as a teacher and head wrestling coach at Boys Town, but live here in Lincoln. Prior to my time at Boys Town I was a youth Outreach worker at inCOMMON community development in Omaha and the Director of Children's Ministry at City Impact here in Lincoln. I have witnessed firsthand the transformative power of community centers for our young people and future leaders in our community, but more over in how they transform entire neighborhoods as well.

Lincoln has always been a place that values our young people, education and invests in the growth and well being of all its residents. However, without these nurturing spaces of belonging that provide opportunities for our youth to learn, engage, and thrive I am very worried for some of Lincoln's most vulnerable citizens; our children. By allowing for the creation of this community center as well as affordable housing proposed by Family Service Lincoln, we would not only meet this critical housing gap, but also create an environment that fosters education, empowerment and positive youth development.

As a teacher and head coach at Boys Town, I have seen the tremendous impact that extracurricular programs and community engagement can have on student's academic performance, personal growth and overall well-being. A community center would provide a safe and inclusive space where young learners could access tutoring services, engage in enrichment programs, and receive academic support beyond the traditional school day. It could serve as a hub for educational workshops, STEAM activities, arts and cultural events and mentoring programs, inspiring a love for learning and cultivating the talents of our future leaders

Furthermore, as a youth outreach worker and program director for children, I have observed the challenges faced by many young individuals who lack supportive environments and positive role models. A community center would serve as a beacon of hope, offering guidance, resources, at a sense of belonging for at-risk youth. By providing mentorship programs, job training initiatives, leadership development opportunities and counseling services, the center would empower young people to overcome adversity and reach their full potential. It would be a place where the can build relationship, gain essential life skills, and discover their passions, setting them on a path toward a successful future. I am reminded at these times a quote by Father Flanagan: "When you help a child today, you write the history of tomorrow."

Beyond the academic and personal development aspects, a community center would contribute to the overall well-being of our residents of all ages. It would provide access to recreational facilities, sports programs, and fitness resources, promoting a healthy and active lifestyle for individuals and families. The center would address the holistic needs of our community, ensuring that every individual has the opportunity to lead a fulfilling and balanced life. Through my time at inCOMMON I saw first hand how our community center: the Park Ave Commons transformed the neighborhood of Park Avenue. While addressing Housing needs and necessary classes such as English class and citizenship classes I witnessed inCOMMON build playgrounds, community gardens and much needed soccer fields in the neighborhood Hanscom Park as they were lead by local leaders spearheading the cause for making their neighborhood better.

In conclusion, I implore the City Council to seriously consider the establishment of a community center at 52nd and Holdrege. By investing in our youth and creating a nurturing environment for their growth, we will not only uplift the current generation but also sow the seeds for a prosperous and vibrant future for our entire community.

I am happy to submit this letter of support for the **Fifty One Commons** project proposed by Family Service.

I am one of the co-founders of BLIXT Locally Grown, a nonprofit organization located in the historic UNI Place neighborhood. We at BLIXT have collaborated with Family Service the past few years, including leading several creative after-school clubs at Dawes Middle School (2021 to present). This past June, we hosted a special theater summer camp for students from Dawes and Goodrich Middle Schools.

Family Service also asked us to host the public meeting about the project, since our Storefront Theater is centrally located in the neighborhood, and easily accessible. We were happy to welcome the neighborhood residents into our space to learn more about the project, ask questions, and voice their concerns.

At BLIXT, we are in support of the project, since we feel it will have a positive impact on the neighborhood. At the moment, a group of creative businesses and nonprofits in the area are in the process of applying for the Creative District certification from Nebraska Arts Council. The Fifty One Commons would be another creative asset in the potential district.

The project will provide an accessible and active space for area youth, and it will also have outdoor spaces for gatherings. As long-term collaborators with Family Service, we are excited about the possibilities the facilities provide. Our Storefront Theater has a maximum capacity of 49, which is ample for most of our activities, but there are times when a larger space would be helpful, for example when we are sharing showcase performances that our campers have created with their families and friends. The project would also provide affordable housing, which would be a tremendous asset to our North Lincoln neighborhood.
