Hello,

I am looking for some help with a Lincoln Landfill issue. I am the owner of Rocket Rolloffs here in Lincoln. We use the landfill Monday through Friday and some weekends. My question is “how can my company be allowed to have an account with the landfill?” We have been using the landfill for almost two years and our usage has been consistently growing. Most haulers are allowed to charge their dump fees and are billed monthly. My company is required to leave a signed check at the window until our daily hauls are done, then we close out the check. We write 5 or 6 checks per week. The other option for our company is to “prepay” our account. This is not desirable as the amount of the charges that we incur are unpredictable. We would need to refill the account weekly and it is not an efficient way to do business.

The reason that I am asking for your help is that I have been unable to resolve this myself. I have asked on multiple occasions to be allowed to charge and have gone through the application process. I am not able to get an answer. In all honesty, the area of landfill administration seems to be “unmanned”. When I call there is no-one to talk to. When I go to the city county building, there is no-one either. I have called LTU, but nobody returns a call. I have emailed the business office; no response.

How can my company be allowed the same privileges as the other businesses?

I need help.

Public Servants (especially county boards and election officials)—

Our **NE State Constitution Preamble** says:

We, the people, grateful to Almighty God for our freedom, do ordain and establish the following declaration of rights and frame of government, as the Constitution of the State of Nebraska.

Article I Section 1 says:

All persons are by nature free and independent, and have certain inherent and inalienable rights; among these are life, liberty, the pursuit of happiness, and the right to keep and bear arms ... and such rights shall not be denied or infringed by the state or any subdivision thereof. To secure these rights, and the protection of property, governments are instituted among people, deriving their just powers from the *consent* of the governed.

Article I Section 22 says:

...there shall be no hindrance or impediment to the right of a qualified voter to exercise the elective franchise.

Thomas Paine, one of our revolutionaries, wrote the following in a [Dissertation on First Principles of Representative Government](#):

"The true and *only true* basis of representative government is **equality of rights.**" ...

"The right of voting for representatives is the primary right by which other rights are protected. To take away this right is to reduce a man to slavery." ...

He goes on to say:

"...the strength and permanent security of government is in proportion to the number of people interested in supporting it. *The true policy therefore is to interest the whole by an equality of rights, for the danger arises from exclusions. It is possible to exclude men from the right of voting, but it is impossible to exclude them from the right of rebelling against that exclusion; and when all other rights are taken away the right of rebellion is made perfect.*"

If you're not catching his drift, the right of rebellion is the right of revolution.

As it stands right now, we are looking at a rebellion.

Why? Because public officials across our state and nation have excluded the People of our Counties from the right of voting, **in as much as** they have excluded us from the right of *equally exercising the elective franchise*.

In other words, they have allowed a very small group of People to decide that they can take our votes and count them in secret. *In secret!*

That is *not* an equality of rights in the exercise of our elective franchise.

...and it produces **no evidence whatsoever** that our representatives are actually

being elected by We the People, and not S-elected by those few counting our votes in secret.

If we are not equal when it comes to exercising our elective franchise, we are not equal anywhere.

A small group of people are playing with fire.

You/they could stop this evil, tyrannical, hijacking of our elections. You/they should stop this evil, tyrannical hijacking of our elections, given your/their oaths.

But you have allowed yourselves to be brainwashed into thinking you work for government (and the likes of people such as our SoS) when in reality you work for We the People.

Don't kid yourself by thinking we are few in number.

There are many more that be with us than be with you.

A storm is brewing in America, the likes of which we have not seen in our lifetimes.

It is sure to come our way, *if* "public servants" don't repent and start becoming Defenders rather than PREtenders.

The Rights in the Second Amendment was explicitly affirmed for the express purpose of deterring exclusions and removing them when they occur.
