RE: Notice of final action by Planning Commission: December 20, 2023

Please be advised that on December 6, 2023, the Lincoln City-Lancaster County Planning Commission adopted the following resolutions:

Resolution PC-01891, approving SPECIAL PERMIT 21022A, to amend and expand the limits of the existing special permit allowing bulk storage of petroleum products in the I-1 Industrial District on approximately 2.04 acres, on property generally located at 1700 Saltillo Road; and

Resolution PC-01892, approving MISCELLANEOUS 23008, to correct Resolution PC-01880 for Special Permit 06068B, The Bridges First Addition, on property general located at SW 27th Street and W. Denton Rd.

The Planning Commission action on these applications is final, unless appealed to the City Council by filing a notice of appeal with the Planning Department within 14 days of the action by the Planning Commission.

As a board member of the Irvingdale Neighborhood Association, I wanted to voice my concern with the large part of Van Dorn Park being used as a storage area for the Lincoln Parks and Recreation Department. I hope that the area can be reclaimed and once again used by the public.

There is a large area of the park that has been inaccessible to Lincolnites because of its use for storage of wood chips, soil and manure. This storage area has expanded through the years, even taking over the space where trees were removed. The former rental shelter nearby has also become a storage space for the Parks and Recreation Department.

The park's recent revitalization with a mountain bike trail, new playground equipment and tree planting has brought people back to the park and attracted new visitors. The park was intended to be a place for the public to enjoy, not to be a place to store heaps of material for the Parks and Recreation Department.

Please restore Van Dorn Park to its original purpose and relocate the materials.

To Whom It Should Concern, Which Is All Of You:

We are not a democracy. We are a constitutional republic.

Who are the rightful sovereigns in a constitutional republic? *The People.*

Quoting our [Nebraska State Constitution](#), the supreme law of Nebraska:

"**We, the people**, grateful to Almighty God for our freedom, *do ordain and establish* the following declaration of rights and *frame of government*, as the Constitution of the State of Nebraska."

And what is that "[frame of government](#)" that "We, the people" did "ordain and establish"?

It's overarching principle is articulated in the very next paragraph ([Article I-1](#)):

"All persons are by nature free and independent, and have certain inherent and inalienable rights; among these are life, liberty, the pursuit of happiness, and the right to keep and bear arms for security or defense of self, family, home . . . and such rights shall not be denied or infringed by the state or any subdivision thereof. To **secure these rights**, and the protection of property, governments are instituted among people, deriving their just powers from **the consent of the governed.**"

So then, in our constitutional republic, government exists for one reason—to *secure our rights*.

And government *servants* exist for one reason—to *secure our rights*.

And those government servants are determined by "**the consent of**" "We, the people."

That's how it's supposed to work, anyway.

What happens when it doesn't?

What happens when "government" is NOT actually determined by the consent of the people because the process of consent has been manipulated and subverted by one or more of the following?

- [fake voters](#)
- [fake ballots](#)
- **[fake](#), secret, computer-manipulated vote [counts](#)**

(What reason is there for secret vote counts *other than* to manipulate and subvert elections?? *There is none.*

There is *not one government person* in this state involved in the administration of our elections who knows what the secret software inside an ES&S machine does during an election. It therefore necessarily follows that there is no way such a person can be in control of and secure an election . . . unless they resort to first conducting a full, transparent, manual count of ballots, from verified

voters only, who deliver their ballots in person. Exceptions include military and legitimate shut-ins.)

What happens?

I'll tell you what happens. A very serious crime happens.

That crime is TREASON.

Treason??

Yes.

Manipulated and subverted elections constitute the overthrow of the rightful sovereigns of our constitutional republic, which is We the People.

And the guilty parties?

Everyone involved in the administration of our elections who is responsible for securing and certifying them, *as well as everyone* who serves in any kind of check and balance capacity by virtue of his or her oath. The responsibility begins with legislators, then the Secretary's office, then county election officials and their deputies, then sheriffs, etc.

One last *question*. Will justice be forthcoming? *We'll find out soon enough.*

One last *thought*. The only reason for elections to go on for days and weeks and months is to manipulate and subvert them. Bad actors can easily monitor mail-in ballots, via USPS tracking services. They can also easily forge signatures, to the end of countering the mail-in vote and/or the overall vote, should it appear to not be going their way. [Forging signatures video.](#)
