Administrative Amendment 23065 to the Antelope Village PUD was approved by the Planning Director on January 9, 2024, to reduce the east front yard setback from ten to zero feet, and to reduce the number of required parking spaces from 14 to 11 on the southwest corner of N 23<sup>rd</sup> and R Street.

Dear Lincoln Housing Authority and City of Lincoln Officials:

I represent Ms. Amanda Proctor on her injury claim arising from a January 20, 2023 accident on the premises owned by the Lincoln Housing Authority at 1742 N. 30th Street here in Lincoln, 68503. Please accept this letter as Ms. Proctor's notification to you pursuant to Nebraska Revised Statutes § 13-905 for purposes of the Political Subdivisions Tort Claims Act. Please also accept this letter as our request for all public records with information on: 1) improvements, repairs, and renovations of the sidewalk and driveway area at the property; 2) the design, installation, modification, and repair of the gutters and downspouts at the property; 3) all complaints made about snow or ice related accidents or falls at 1742 N. 30th Street in the five years before Ms. Proctor's accident; and 4) all complaints about snow or ice related falls or accidents at any other Lincoln Housing Authority properties with similar gutter and downspout configurations.

On the morning of January 20, 2023, Ms. Proctor was leaving the north side of the duplex residence to drive her fiancé to work. Her fiancé had previously cleared the front walkway of snow, as required by the lease. However, the gutter and downspout system at the property caused water draining from the downspout to re-freeze on the walkway

on the front/west side of the residence, at or near its junction with the driveway. This is an area of frequent foot travel for the residents, visitors, and people engaged in commercial activity like package delivery. It was entirely foreseeable that this gutter and downspout arrangement would lead to a thaw-and-refreeze condition on the walkway despite the best efforts of the tenants to keep the sidewalk free of snow and ice.

As Ms. Proctor was walking to her vehicle parked in the driveway, carrying her child, she stepped onto an essentially "black ice" condition on the walkway. Ms. Proctor came down hard on the paved walkway. The good news is that her child was secured in a child safety seat and sustained no injuries. Ms. Proctor, however, sustained a bimalleolar fracture of her left ankle requiring an open reduction/internal fixation surgery by Dr. Joshua Vest. The fracture was displaced. Dr. Vest had to re-align the bone and use a plate and screws to repair the damage.

Over the last nine-plus months Ms. Proctor has worked to slowly recover the ability to walk in a halfway normal way and to slowly resume day-to-day activities. This has been difficult for a mother of four children. She has residual pain, limitation of motion and swelling because of her left ankle injury. She continues to have trouble with uneven surfaces and prolonged standing. Weather changes cause additional pain.

With this letter, we are providing you with some photographs of the area where Ms. Proctor sustained her injury. We will be interested to see in the requested records what consideration the Housing Authority gave to alternative gutter and downspout drainage options. Further, the driveway very near the area where the accident happened appears to be much newer in the sidewalk area. We will be interested to see in the requested records why no modification was made to the gutter and downspout system when the more recent driveway work was done.

While a private individual residing in his or her own residence might choose to have this type of drainage system -- accepting the risk of the thaw-and-refreeze cycle -- we do not believe a fact-finder would conclude it was reasonable to create this condition and allow it to persist at a rental property where the Housing Authority knew or should have known it created a hazard. This is especially true when the lease required Ms. Proctor and her family to keep the walk free of snow and ice, on risk of penalty. In other words, we do not believe it was an exercise of reasonable care for the Housing Authority to perpetuate this dangerous condition unless it, as the landlord, was also prepared to have its staff provide services for snow and ice clearing, salting, and/or sanding.

With this letter, we are providing you a summary of Ms. Proctor's treatment and an itemization of the related medical bills we have gathered to date, totaling \$45,416.05. We are providing to the City Attorney's office only the actual records and bills of the providers identified in that itemization.

This letter is in response to the above claim filed in the City Clerk's Office and City Attorney's Office on November 20, 2023, on behalf of Amanda Proctor. As stated in your letter, this claim involves a slip and fall on January 20, 2023, at 1742 N. 30<sup>th</sup> Street, Lincoln, Nebraska, which is property owned by the Lincoln Housing Authority.

This office is charged with the responsibility of investigating the merits of claims filed against the City of Lincoln in order to make a recommendation to the Lincoln City Council. Pursuant to state statute, the Lincoln Housing Authority is a separate political subdivision from the City of Lincoln. See Neb. Rev. Stat. § 71-1575(16) ("A local housing agency shall be a political subdivision of this state, independent from the city or county which established or establishes it or which may appoint some or all of its commissioners"). As the Lincoln Housing Authority is a separate political subdivision from the City, the City would not be the proper party for this claim. Accordingly, I must forward this claim to the Lincoln City Council with a recommendation that it be denied.

The Lincoln City Council will consider this claim at its regularly scheduled meeting on January 29, 2024, at 5:30 p.m. in the Council Chambers, 555 South 10<sup>th</sup> Street, Suite 112.
