East-West Alley, Between 13th & 14th Street, D and E Streets

A request has been made to vacate the western 133 feet of the east-west alley located between E and D Streets, west of 13th Street. The area to be vacated is 16' x 133' feet and approximately 2,148 square feet in size. The writer viewed the property, and the area is currently fenced in because of demolition work and overhead utility lines traverse the alley. A sanitary sewer line resides in the alley, and LES has requested an easement be retained for existing overhead utilities that will be buried in connection with the proposed redevelopment project. According to the staff report, after the vacation the adjacent properties will be replatted, a public access easement will be granted for public and private vehicles to utilize, and the developer will be responsible for maintenance on the remaining portion of the alley. No other utilities appear to be in the affected area.

The property will not differ in use after the vacation other than it will be privately and not publicly owned. It is currently adjacent to B-3/R-7 zoning and will assume a similar value to those properties, but because of the access and utility easements to be retained it has limited development potential and a reduced value.

Research of some comparable sales indicates a value range from \$10.33/sf to \$21.06/sf and the writer deems this property could support a value of approximately \$13.00/sf. Because of the retention of the easements, a percentage of the underlying land value is considered appropriate especially for assemblage purposes and a discounted rate of 20% will be used. With that, the area to be vacated is calculated as follows:

 $2,148 \text{ sf x } $13.00 \times 20\% = $5,585$

Therefore, if the area is to be vacated, it is recommended that the area be sold to the applicant for \$5,585.

I am grateful to Lincoln Parks and Recreation for many many provisions, including prairie native plantings and especially mulch circles around trees to save them from mower damage. But this memo is to call your intention to some inevitable negative consequences if the Woods Tennis proposals to encroach further on Woods Park were to be approved. These consequences are environmental and I have not heard them addressed so far in the debate. I wish I could make them as vivid to you as they are to me. Please lend this memo your thoughtful consideration.

The most fundamental issue is quite simply increasing impermeable surfaces: paving and buildings that cannot absorb water. This describes an essential characteristic of roofs, sidewalks, parking lots, streets, driveways and hard-surfaced tennis and basketball courts. Let me use the word "hardscapes" to refer to all such surfaces. Hardscapes exaggerate whatever weather they inhabit: they reflect and magnify heat or cold, and we know that climate change means more and more weather that is already extreme: hot vs cold, wind vs stale air (heat and smoke inversion), rain vs drought. Living landscapes have the opposite effects: they do us the immense favor of modifying weather.

Moreover, and of critical importance for a dense hilly neighborhood, hardscapes repel water, increasing the volume and intensity and pollution of run-off and its negative impacts. Every SQUARE FOOT OF HARDSCAPE REPELS MORE THAN SIX (6) **GALLONS** of water per **ONE INCH OF RAIN.** For every inch of rainfall there will be an increased run-off of **SIX HUNDRED GALLONS** of water for every 100 square feet, a rectangle only ten feet on a side. Five hundred square feet equals **3,000 gallons**. One acre = **27,154 gallons**. Two acres = **54,308 gallons**. Turning two acres of porous grass-covered soil into hardscape means turning more than 54,000 gallons of water running off downhill into neighborhoods south and west of the park **per inch of rain**.

Suppose we get three inches and more of rain (which is hardly extreme): the proposed 2 acres times ¼ foot equals ½ acre-foot or 195,510.8562; **nearly 200,000 gallon**s of water RUN-OFF. This is serious business. And sometimes that three inches comes in an hour or two.

Consequences of such run-off:

- Flooding basements, eroding gardens and yards. Such property damage is not some "small sacrifice."
- 2. Increased downhill spill of automotive and human waste (cigarette butts, leaking oil, plastics, etc.) from more parking and driving areas.
- 3. Thousands of gallons more of what had been fresh water flowing into our sewer systems.
- 4. Further flooding of downhill (southwest) park areas like the volleyball sandlot and trees in flatter areas. Since the big metal tennis barns were built just a few years ago the southwest downhill area has been flooded regularly, even pooling water on the paved walkways-- run-off that is also eroding the park's grassy slope hill. One of my favorite benches is often situated in a pool up to an inch deep. That can't be good for the trees or grasses down there, or for the metal bench. Or for park users who have to wade through the water

Green expanses do much more than sequester and preserve water. They cool and humidify the air above them, and actually create small hydrologic cycles. The roots of green plants do "plant" carbon in the soil, thereby extracting it from the atmosphere and sequestering it. Every single tree is a living carbon sequestration. Each tree that dies releases carbon into the atmosphere whether it is burned, chipped, piled up or buried. And the carbon is also in roots, twice the size of the tree we see above ground. A streetside "planter tree" is not even half as effective and does nothing for water cycles and is irrelevant to mention in the same breath as trees in green grassy areas where they belong. Ever sit and read beneath a planter in a parking lot?

And, finally, that which enables all animal life, including human beings: the "green" that is not just a color but a process which seems to be unique in the universe. Earth would have no oxygen for animals to breathe were it not for a small miracle called photosynthesis: the process whereby green plants, as living beings, use sunlight to EXTRACT CARBON from the atmosphere and PRODUCE FREE OXYGEN. There is no other atmospheric source of oxygen in air.

This is just science. These facts have no opinion or prejudice about a particular human sport called tennis. The facts persuade me that the more green space on earth and the less impermeable hardscape the better. We need to concentrate our impermeable surfaces in areas of city blight where green space is already impacted: e.g., redevelopment of abandoned buildings where there is already plenty of parking space and traffic and artificial light. Downtown? Near the UNL campus? The Telegraph redevelopment which is already in central traffic area?

When tennis was an outdoor sport, it made sense to build the courts in the open space of a park, but indoor tennis is really an ugly and cruel incursion on the very nature of a park, and taking park space for cars is even more misguided.

It is my considered opinion that we really must not expand environmental blight by killing forty mature and healthy trees (or 38 or 30 or any) and destroying the coherence of rooted grassy expanses. We should not impinge further on the breath-taking and breath-giving presence of green horizon profiles. Our love of nature is not just an aesthetic sense: it may well be the remnant of a wise appreciation of earth's green processes upon which our lives depend.

Opinions about tennis are unimportant and irrelevant when it comes to the costs of the climate disaster already upon us. Two weeks ago, in mid-February in Lincoln we witnessed eighty-degree days and non-freezing nights with the soil already UNFROZEN. Now this first week of March we are running more than ten degrees warmer than average or expected. Climate change is here, now, not in some distant and fuzzy future possibility. All plants are stressed from these irregular extremes: grass, shrubs, and the precious trees of our Historical Bur Oak District. We should not be replacing green parks in town but doing everything we can to preserve that which makes Lincoln a city of trees, one of its most valuable features. Just casually let me throw out a fact which science confirms; that the presence of grass and space and trees leads to a reduction in both violent and property crimes. Maybe it's all that fresh oxygen!
