SUBJECT: End of Year deadlines for payment vouchers, requisitions, budget, etc., to be charged to FY2024/2025 Budget

<u>PURCHASE REQUISITIONS</u> - In order to close-out the fiscal year, a PO must be executed by **Monday, August 18, 2025.** To achieve this, requisition cut-offs will be as follows:

All purchases that will require a bid/quote and subsequent purchase order must be entered into JDE by **Wednesday**, **June 18**, **2025.** This includes any purchase over \$50,000.00. Remember, if you believe it is going to be close to the \$50,000.00 threshold, it is best to use the Formal Bid Process as quotes that come in over \$50,000.00 are rejected and a new formal bid issued.

Any requisition submitted for PO from contract must be entered into JDE by Monday, August 11, 2025. Any requisition entered after August 11th will be held and processed after September 1, 2025.

Deadlines have been set to allow time for EO's, DO's, and any other approvals that may be required to complete a PO.

<u>PAYMENT VOUCHERS, INTER-DEPARTMENTAL TRANSFERS AND ESTIMATES FOR PAYMENTS</u> must be received in Finance no later than <u>Wednesday</u>, <u>August 20</u>, <u>2025</u>. Even though the above Payment Vouchers will be charged to August expenditures, a check may not be written until September. The Accounts Payable module in JDE will be shut down from August 21st through August 31st. Vouchering will resume September 1st for the new fiscal year.

MISCELLANEOUS ENCUMBRANCES (other than purchase orders and contracts which are entered into JDE) must be submitted to the attention of Melinda Jones in writing by 4:30 on Wednesday, August 6, 2025, for review. Keep in mind that encumbrances must be covered by a contract. Requests to reappropriate balances that are not encumbered by PO or Miscellaneous Encumbrance through the budget resolution are due to the Budget Office on Thursday, July 3, 2025.

TRAVEL ADVANCES: If a trip ends before the end of August, please get the expense statement and any money to be returned to Finance Accounting no later than **12:00 P.M. on Wednesday, August 20, 2025**, so that the return money can be credited to the 2024-2025 budget, otherwise it will be considered a prior-year refund in 2025-2026.

<u>P-CARD PURCHASES:</u> P-Card transactions will need to post to the August Statement to be charged against the current year budget. The billing cycle closes on August 25th, so we recommend payments be made before August 18th. P-Card transactions that do not post to the August Statement will be charged to the 2025-2026 budget.

Purchase Orders (PO) should not be paid with a P-Card now or during the fiscal year. You need to voucher against the PO in order to release the encumbrance. P-Cards do not release an encumbrance.

Any of the above documents not received by the appropriate deadline will be considered 2025-2026 business.



Climate Up Close was founded to make the essentials of climate science accessible to a broad audience. Composed of working climate scientists from **Cornell University**, **Harvard University**, and **Princeton University**, Climate Up Close is independent, nonpartisan, and nonprescriptive. The group's presentations are aimed at an audience with diverse views and seek to provide a science-based, common language for discussion. The scientists strive to build trust and partnership between the scientific community and the larger public.

Climate Up Close events are free and open to the public. The group has previously toured central Pennsylvania, the greater Philadelphia area, central New Jersey, the Florida panhandle, the greater Chicago area, and central New Hampshire, and has reached more than 2500 attendees from the general public, from those already engaged to some degree in climate activism to those who came to the conversation from a more skeptical perspective.

Climate Up Close co-founder Nathaniel Tarshish: I left physics to study climate science based on an impression of climate change that was shaped by reading the popular press. Pursuing a PhD in climate science has substantially changed my views. I think many people are in the same position I was in, and feel bombarded by a media storm of conflicting messages on climate change. My goal is to take what I've learned about the complexities of climate change and communicate it to the public at large.

Climate Up Close co-founder Aaron Match: Throughout our history, Americans have often transformed healthy disagreement into pragmatic strength. Climate politics has lots of disagreement, but it's not healthy. It's hard to talk about climate change across the aisle or across the Thanksgiving table. I co-founded Climate Up Close because I envision a healthy climate conversation—one that acknowledges scientific uncertainty and welcomes different values. Our presentations are the start of that conversation, and I hope to meet you there.

Climate Up Close scientist Andrew Williams: This will be my second tour with Climate Up Close, and I'm thrilled to bring the conversation to Nebraska. I look forward to engaging with communities across the state as we explore the science behind climate change together. What aspects of climate science are truly 'settled'? Where is the boundary of our knowledge? What would need to be done to halt global warming? Come along, and let's explore these questions, and more!

Jim Cook, Saint Paul UMC: Speaking for the four sponsoring organizations here in Lincoln, we are all very excited for this opportunity to host the Climate Up Close scientists on June 26 to 29. As a member of one of those four, Saint Paul UMC whose mission includes caring for God's creation, I know that the need to protect and care for that creation is more important today than ever.
