

Lincoln-Lancaster County Health Department Air Quality Program 40 CFR Part 63 Subpart HHHHHHH – Petition for Exemption

What is the purpose of this rule?

• The United States Environmental Protection agency (US EPA) issued 40 CFR Part 63, Subpart HHHHHH (National Emission Standards for Hazardous Air Pollutants for Source Category: Paint Stripping and Miscellaneous Surface Coating Operations at Area Sources) to establish emission limitations and standards to reduce/control hazardous air pollutants (HAP) emitted from paint stripping operations, autobody refinishing operations, and operations that perform paint spraying of metal and plastic parts and substrates. This subpart only applies to such operations that are 'area sources' of HAPs. An area source is a facility with total potential to emit less than 10 tons of any individual HAP, and less than 25 tons of total combined HAPs.

How do I know if I qualify for the exemption?

- Motor vehicle and mobile equipment surface coating operations that use only coatings that do not meet the definition
 of 'target HAP-containing coatings' can qualify for the exemption. Facilities for which both of the following statements
 are true may be qualified:
 - All coatings used at your motor vehicle or mobile equipment surface coating operation contain no more than 0.1% by mass of known human carcinogens, which includes cadmium (Cd) compounds, hexavalent chromium [Cr(VI)] compounds, lead (Pb) compounds, and nickel (Ni) compounds.
 - All coatings used at your motor vehicle or mobile equipment surface coating operation contain <u>no more than 1.0%</u>
 by mass of other chromium (Cr) compounds (e.g. trivalent chromium) and manganese (Mn) compounds.

What painting spraying and paint stripping activities are not subject to this rule?

- The following activities <u>are not</u> subject to Subpart HHHHHH, and facilities that only conduct these activities <u>do not</u> need to submit a petition for exemption from Subpart HHHHHH:
 - o 'Facility maintenance', painting of 'space vehicles', 'research/laboratory activities', and 'quality control activities' as defined in Subpart HHHHHH;
 - Painting using non-refillable aerosol cans, hand-held device with a paint cup capacity that is less than or equal to
 3 fluid ounces, powder coating, or other non-spray painting methods;
 - Paint spraying/paint stripping performed at U.S. military installations, painting of military munitions, painting of equipment used directly and exclusively to transport military munitions;
 - O Hobby/maintenance painting by individuals on their personal vehicles/possessions/ property, provided that individuals do not apply spray coating to more than two vehicles or pieces of mobile equipment per year.

What is the purpose of this form, and when do I need to submit it?

- The purpose of this form is to exempt your source from the requirements of Subpart HHHHHH that apply to surface coating operations.
- You can submit this form at any time, provided that you are able to certify that you qualify for the exemption at the
 time of submittal. If you are starting-up a new source, and would like to be exempt from the rule at the time of startup, then you should submit this form at the same time you submit the 'Initial Notification/Notification of Compliance
 Status' for your facility.
- This document <u>must</u> be signed and certified by an individual who meets the definition of a 'Responsible Official' set forth in <u>Article 2, Section 1 of the Lincoln-Lancaster County Air Pollution Control Program Regulations and Standards</u>.

If circumstances change such that we intend to spray-apply target HAP-containing coatings in surface coating operations, we will submit the initial notification required by 40 Part 63, Subpart HHHHHHH §63.11175 and will comply with the requirements of Subpart HHHHHHH. Spray application of target HAP-containing coatings in a surface coating operation voids any exemption that might be granted as a result of this petition.
