

Mayor's Water Source Advisory Council Chartering Agreement

Background

The City of Lincoln is pursuing **Water Supply Development for Lincoln Water System – Phase 1**. The Project will determine an additional water supply source for the Lincoln Water System (LWS). A second water supply will enable Lincoln to continue to grow and provide resiliency against drought, natural disasters and other events that can impact source water supply capacity and quality.

Previous Facilities Master Plans (FMP) have recommended an additional source of water supply for the City of Lincoln based on projections of customer demand and supply capacity of the existing Platte River wellfields. The most recent FMP 2020 indicates that the wellfields will reach their full capacity in 2048 and an additional and resilient supply will be necessary. Securing additional water supplies from other sources and locations is a large and complex initiative requiring our community to begin this process well in advance of projected supply deficits.

The City will be consulting experts and a broad-based group of stakeholders to obtain feedback to help inform decisions about securing a second water supply. The Mayor's Advisory Council on Water Supply Development will reflect a broad range of individuals representing different stakeholder perspectives and the City as a whole. The Mayor's Advisory Council on Water Supply Development is anticipated to meet over the remainder of 2022 and provide a final report with recommendations to the City in January 2023. The City is then anticipated to make decisions on a path forward for Water Supply Development for Lincoln Water System – Phase 1 in the first part of 2023.

Mission Statement

The mission of the Mayor's Advisory Council on Water Supply Development is to provide feedback and input to the City on criteria, alternatives and priorities for a second water supply that will enable Lincoln to continue to grow and provide resiliency against drought, natural disasters and other events that can impact source water supply capacity and quality.

Advisory Council Meeting Process

- The Advisory Council deliberation process is collaborative problem solving.
- All perspectives are valued, and alternative perspectives will be documented.
- The Chair with the assistance of Olsson, the consultant hired to provide technical and facilitation support, will administer the meetings.
- In the absence of the Chair, the Vice Chair will administer the meetings with the assistance of Olsson.
- Meeting discussions may be audio taped to aid in the preparation of meeting summaries.

Meeting Attendance

In order for the process to work effectively, full participation of Advisory Council members will be essential. Advisory Council members are asked to commit to attend meetings consistently and are asked to not miss more than one meeting. A complete meeting schedule will be provided up-front, with meetings held monthly on the third Tuesday from 10:00 a.m. – 2:00 p.m. at the Lincoln Chamber of Commerce Offices, 1128 Lincoln Mall. Breaks and meals will be provided during each four (4)-hour meeting. If an Advisory Council member becomes unavailable to continue to attend meetings, they should inform the Chair and may suggest an alternate for appointment as their replacement. If accepted by the Chair, the alternate will need to be briefed by staff regarding the status of prior discussions and decisions.

Meeting Agendas

Advisory Council participation in establishment of agendas and matters of discussion will be encouraged. LWS staff and the facilitator will be responsible for preparing the agendas in collaboration with the Advisory Council Chair and members. At the conclusion of each meeting, staff and Advisory Council members may suggest items for inclusion in the next agenda and any action items requiring additional research. In cases where inclusion of items on an agenda is not consistent with the effort to keep the process moving forward, staff will provide a plan to vet the suggested items.





Public Meetings

The meetings are public; however, Advisory Council members are asked to refrain from making public statements about the Advisory Council's deliberations to the media. Members of the public will have the opportunity to give public comment during each meeting. Every Advisory Council member is asked to report back to his or her respective constituency to keep them aware of the Advisory Council's discussions and developing input. LWS staff and Olsson will be available to assist in this communication process, if desired. The City will be responsible for communication efforts related to second source water supply development and the Advisory Council's work.

Information For Advisory Council

To ensure that all Advisory Council members have the same information available to them, all documents will be distributed through the established point of contact for the Mayor's Advisory Council on Water Supply Development. Advisory Council members are asked to provide any materials five (5) business days prior to the meeting, whenever possible, for distribution to the Advisory Council at least three (3) days before the next meeting.
