 Committee Chairperson Brandt introduced the Mountain Bike Facilities master plan agenda item noting that the full plan could be viewed at lincoln.ne.gov keyword Mountain Bike.

Sara Hartzell provided a review of the overall process which included board/committee representatives along with members of the public, resulting master plan (copy attached to official minutes on record). A motion was made by Jim Crook and seconded by Katie Graff to approve the Master Plan for Mountain Bike Facilities in Public Places as presented.
