**AMENDMENT TO AGREEMENT BETWEEN
RURAL WATER DISTRICT NO. 1 AND CITY OF LINCOLN**

The Agreement Regarding Annexation Fees ("Agreement") by and between Rural Water District No. 1, Lancaster County, Nebraska ("RWD") and City of Lincoln, Nebraska ("City"), authorized pursuant to Resolution No. A-87575 by Lincoln City Council on September 30, 2013, shall be hereby amended to modify paragraph 3(d) as follows:

Annual Fee Adjustment. The annexation fee shall be adjusted annually starting in January 2015. The adjustment will be in an amount equal to the percent change in the Consumer Price Index – For All Urban Customers (CPI-U) for the period from ~~November 1~~ October of the current year to ~~October 31~~ of the prior year to take effect the following January 1. If the herein referenced Consumer Price Index is discontinued, the parties shall apply the most comparable price index available.


The remainder of the Agreement shall remain in force and effect as of the date of its original effective date.
