CPAB Member Training - Cameya Ramirez-Rousseau inquired whether other members would find enhanced training valuable to help them feel confident while serving in their roles. This idea was well received. It was discussed that Shirley Mora James had previously created guidelines to assist members with the informal hearing process. A review of all rules and regulations would be helpful. It was agreed a small committee would be formed to include Tonya Peters and together they will create an updated, comprehensive curriculum to present in early 2024.
