This program applies to at-risk trees, defined as trees that are dead, fatally diseased, or structurally weak. Ash trees at risk for Emerald Ash Borer may also qualify for assistance.

Removing mature trees can be COSTLY and beyond one's means but this grant program can help!



### AT-RISK TREE REMOVAL AND REPLANTING PROGRAM

# The following <u>eligibility</u> requirements apply:

- Property owner must reside at the property
- •Have an income at or below 80% of Area Median Income (refer to table below)
- •Tree must meet the definition of an at-risk tree and be verified through a Tree Risk Assessment – included at no cost
- •Property owner must complete an application and provide the required documentation to be qualified for the assistance

After an applicant's eligibility has been approved:

- A Tree Risk Assessment will be completed by an approved arborist and if the tree is verified at-risk, the property owner is responsible for securing two (2) written estimates from a list of prequalified and licensed companies that the Urban Development Department will provide to the property owner.
- The Lincoln Parks and Recreation Department will review and select the most competitive estimate and the property owner will be notified.
- The removal of the tree will be scheduled and coordinated by the property owner and the selected company.
- The Urban Development
   Department will make payment directly to the tree removal company.
- Property owner will be contacted to schedule the new tree planting. Tree planting season is spring and fall.
   Education on how to plant and maintain the new tree will be provided.
