RMS Reported Rapes Updated 2021

This document pertains to follow-up to prior reports regarding LPD Sexual Assault "reported cases" and the potential impact of the #metoo movement. In viewing the results from the years 2000, 2005, 2010 and 2015, it is believed since 2018, totals reflect the #metoo movement, which potentially allows victims to feel more comfortable in coming forward to report sexual assaults that may have occurred years ago. For example, in 2020, 23.7% of sexual assault cases reported to LPD occurred at least one year prior to the reported date, compared to 11.7% in 2015. The effects of this movement peaked in 2019 with a slow decline of reported cases through 2021.

Defining Table 1:

Reported = Cases reported to LPD, which include "unfounded"

1 Year = Number of cases reported to LPD more than one year from the date the incident occurred

Average = Number of days between the reported date and the date the incident occurred

Median = Value at the midpoint of all the values

Percentage = The number of cases reported more than one year after the date the incident occurred, compared to the total number of reported cases
