Medicare Hospice Care – Medicare pays for hospice care for terminally ill beneficiaries who choose to receive hospice care rather than regular Medicare benefits for management of their illness. Medicare hospice is a program of care generally provided in the patient’s home by a Medicare approved hospice provider. The focus is on care and not cure.

Ask your hospice care provider about specific Medicare coverage.
