These facilities provide meals, accommodations and an array of supportive services designed to meet individual needs. They also provide privacy and promote independence in residential surroundings.

Assisted living facilities that participate in the Medicaid Waiver Program are considered to be "Medicaid Waiver Certified."

This allows Medicaid recipients with qualifying health issues to stay in their facility. Some certified facilities may only accept in-house waiver conversions. Conversions are those residents that have a history of private pay but will now need Medicaid to be able to stay with them. Please check with the facility!
