YES NO Temporary Food Servers: LLCHD by policy allows that temporary volunteer food servers not preparing food, to be exempted from food handler permit requirements if they are trained as pre-approved by LLCHD, have no bare hand contact of foods, sign a "Temporary Food Server Roster" verifying training, and sign a "Required Illness Affirmation" form verifying that the server has not had vomiting or diarrhea within 48 hours of working at the temporary event.
